Hi Angela/Owen

Further to our discussion this morning I went back and had a look at the SIDRA modelling and found that I had not saved the recent runs (which I sent yesterday). Please delete the SIDRA file sent yesterday and replace with the attached file.

In addition I have rerun the SIDRA files assuming that a proportion of traffic exiting the site to the north, east or south would turn left out of Coolinga Street onto Waterloo Road, undertake a u-turn at the Khartoum Road roundabout and then turn left, through or right turn onto Lane Cove Road. The PARAMICS modelling found that traffic used other routes.

I assumed that 50% of traffic wanting to go north turned left onto Lane Cove Road, 33% of wanting to travel east went through the intersection, 33% of traffic travelling east and 50% of the traffic wanting to go south turned right onto Lane Cove Road.

The revised SIDRA is attached and summarised below.

AM + Dev, average delay 73s, LOS E

PM + Dev, average delay 48s, LOS D

AM + Dev + G-Turn, average delay 67s, LOS E

PM + Dev, + G- Turn average delay 46s, LOS D

These results are similar to the recent runs.
