

# 5 DIRECTOR GENERAL'S REQUIREMENTS

Following a formal request by the proponent, and a Planning Focus Meeting of key stakeholders at the Department of Planning on 7 February 2006, on 5 April 2006 the Director General issued formal requirements (DGRs) for the preparation of the Environmental Assessment (EA) for the project.
