The purpose of this letter is to notify the NSW Department of Planning and Infrastructure about amendments to the Major Project application for Rugby Wind Farm- MP10\_0194 (the Project).

In 2011, Suzlon Energy Australia Pty Ltd and REpower Australia Pty Ltd combined their operations in Australia and are now trading as REpower Australia Pty Ltd.

As a consequence, REpower Australia is now the Proponent of the proposed Rugby Wind Farm the purpose of this application.

Due to amendments to the design of the Project made in response to feedback from a variety of stakeholders and the release of the 2011 NSW Draft Planning Guidelines: Wind Farms, the set of parcels comprising the Project Application Area (PAA) has reduced significantly.

A small number of additional parcels have also been added to the PAA as a consequence of iternations in the Project's Design.

The Lot and DPs of the amended PAA are shown in the table overleaf, and an updated map of the PAA has been attached this letter.
