#### PART B - PRIOR TO ISSUE OF CONSTRUCTION CERTIFICATE

## Insert new Conditions B22 - B31:

#### Remediation

- Remediation works shall be carried out in accordance with Remedial Action Plan titled Remedial Action Plan, Identified Asbestos Contamination, Proposed Wet n' Wild Theme Park, Reservoir Rd, Prospect prepared by SLR Consulting Australia Pty Ltd dated 18 December 2012 (RAP) submitted with the Section 75W Modification Report titled Section 75W of the EP&A Act, Modification Application, Wet 'n' Wild, Remediation of Lot 1 in DP 1045771 prepared by JBA Planning dated December 2012.
- B23 Prior to the commencement of remediation work, a Part B Site Audit Statement shall be prepared by an EPA accredited site auditor and submitted to the certifying authority. The Part B Site Audit Statement shall verify that the RAP and remediation strategy adheres to appropriate standards, procedures and guidelines, and will render the site suitable for use as a water theme park.
- Prior to the commencement of remediation work, the Construction Management Plan (see Condition B4 of this approval) must be updated with all mitigation and management measures detailed in Section 13 of the RAP (page 37 40 of the RAP) and submitted to the certifying authority.
- Prior to the commencement of remediation work, the proponent must obtain an environmental protection license (EPL) from the EPA for remediation works that are deemed a scheduled activity under clause 15 of schedule 1 of the *Protection of the Environment Operations Act 1997*. The remediation works must be undertaken in accordance with any requirements of the EPL.

- B26 Notwithstanding the contamination containment cell location plan in Appendix H of the RAP, the location of the contamination containment cells must be in accordance with the drawing titled *Wet 'n' Wild Sydney Overall Bulk Earthworks Plan* dated 21/09/2012 submitted with the Response to Submissions Letter titled *Wet n Wild Sydney (10\_0190) Modification 1 Response to Submissions* prepared by JBA Planning dated 24 April 2013.
- B27 The remediation work must be undertaken in accordance with the conditions detailed in Appendix A of the EPA's submission dated 25 March 2013 provided on the Section 75W Modification Report titled Section 75W of the EP&A Act, Modification Application, Wet 'n' Wild, Remediation of Lot 1 in DP 1045771 prepared by JBA Planning dated December 2012.
- B28 The remediation work must be undertaken in accordance with the approved hours of work in Condition D1 of this approval.
- A site management plan (SMP) shall be prepared which will detail the location and lateral and vertical extent of the containment cells, the nature of the contained contamination, measures to maintain the integrity of the containment cells, on-going monitoring program, and procedures to ensure appropriate restoration of the capping layer, in the event that any excavation works or installation of underground services encroach into the capping layer. The SMP shall be reviewed and approved by an EPA accredited site auditor prior to the issue of any Section A Site Audit Statement. The SMP must be registered on the property title at the completion of remediation works.
- B30 Upon completion of remediation works on the subject site, the proponent must provide a notice of completion of remediation work in accordance with clause 17 and 18 of State Environmental Planning Policy no 55 Remediation of Land. Additionally, the proponent must engage an appropriately qualified contamination consultant to prepare a validation report which is to verify that the site has been remediated in accordance with the RAP, and any conditions contained in this approval.
- B31 Prior to the issue of any occupation certificate or commencement of use, an EPA accredited site auditor must approve the validation report referred to in Condition B30 and provide a Section A Site Audit Statement stating that the site has been appropriately remediated and is suitable for use as a water theme park. The site auditors approval of the validation report and Section A Site Audit Statement must be provided to the PCA and council prior to the issue of any occupation certificate or commencement of use.

Note: Words and expressions used in these conditions have the same meaning as in the Contaminated Land Management Act 1997.

Note: The remediation of asbestos contamination must be undertaken in accordance with the licensing and notification requirements of WorkCover NSW and the Work Health and Safety Regulation 2011

Note: The remediation works must be undertake in accordance with any relevant special waste procedures detailed in the Protection of the Environment Operations (Waste) Regulation 2005
