Reference is made to the Comberto Grange Shaolin Temple Proposal  
 The EIS is presently on public exhibition for submissions approx 14 days to go

We are concerned that there is located on this land a valuable source of rock that has been assessed as suitable for the proposed Breakwater for the Boat harbour proposal, and the source is so close less than 10klm

It has been disclosed that the Deposit for the land has still not been finalised and that Shoalhaven Council is subsidising this until the State Planning Dept approves the plans for the Temple development, we therefore assume it is still owned by the Council and are concerned that this source of rock could be lost. We wish to ensure that this is clearly itemised in our submission.

We would appreciate any information that the Dept has and considers would be helpful in our submission.

Does the Dept intend to do any further assessment of this material, is it appropriate in view of the Boat Harbour proposal progressing forward.

We have numerous meeting planned in the immediate future and are expected to submit to this EIS
