I am forwarding this email to you in the hope that you will read and understand that the Comberton Grange /Shaolin Temple Environmental Assessment has now been released for public comment.

Only two locations host 'The Shaolin Plan' in physical paper form.

These two locations are the; Shoalhaven City Council Administration Centre in Nowra NSW and The Head Office of the NSW Department of Planning in Sydney NSW.

This is inadequate.

I believe a copy should be made available in each and every Shoalhaven City Library including the Mobile Library for Public viewing and convenience .

I also believe 'The Shaolin Plan' should be further interpreted and explained by the NSW Government and Private Interests; through a series of Public meetings held in each of the affected towns and villages of the Shoalhaven City and the JERVIS BAY TERRITORY.

This will give the Public; the Community impacted by this proposal; a clear understanding of the vision of 'The Shaolin Plan' and the shared impact upon the Shoalhaven City , the natural and cultural heritage of The Jervis Bay Regional Environment and our individual and shared communities .

Dear All,

The NSW Government's advice regarding transitional part 3A projects maintains the public's right to respond to development applications within a minimum exhibition period of 30 days.

The just released Shaolin assessment is a huge complex document dealing with extensive development of sensitive coastal land. The public are required to view, assess and respond by 04 December 12.

The project has been rattling around for over 6 years. The Government have provided one paper copy only of the assessment with limited access in Nowra. The 30 day allowance for electronic viewing, assessing and responding is not really enough. These limits on time and availability are contemptuous of the public interest.

Please, as a first step in dealing with this ask for an extension of the 30 day limit and additional copies to be displayed locally for the paper dependent.
