Apologies for not getting this to you sooner, I think there must have been some crossed wires between Owen and myself.

I have attached a zip file containing all of the intersection models that were used in our assessment. RMS should have the software to run these files.

With regard to the request for a calibration and validation report, it is not generally required to provide a calibration and validation report for SIDRA intersection modelling, unless specific changes were made from accepted values. From recollection, we did not make any of these changes. I would refer RMS to page 194 of the RMS Modelling Guidelines (2013), in particular section 14.4.

If there are any other issues, please let me know, we are happy to accommodate and suggestions or changes from RMS in the next round of modelling.
