As a resident of the local community and, thereby, a stakeholder in what happens to the Channel 9 site I want to express my objection to the Preferred Project Report (PPR) mentioned above. My concern is the inappropriate redidential density of the proposal. Far more preferable would be one in the nature of and with the limitations of that proposed by Willoughby Council.

At a Community Meeting held on May 7, 2013, over 200 people agreed that residential redevelopment of the site was an appropriate use but that the proposed 600 apartments and up to 18-storey buildings was not. The meeting went on to unanimously endorse Willoughby Council's alternative proposal for 300 apartments and a maximum building height of eight stories as acceptable to the community. However, the current PPR still exceeds the Council proposal by fifty percent in density and building height. Still, despite community objection, we are faced with gross over-development within a single dwelling neighbourhood somewhat distant from a mass transit hub. It would significant additional strain on nearby roads, public transport, council facilities, schools and local parking.

Even though Channel 9 initially stated a policy of community involvement its comittment to this and to contact with Council was minimal. Responses to the Public Exhibition and to a petition that garnered over 2,300 signatures opposed to the development has, it seems, taken effect but not to the desired extent; the community was left needing to take action to maintain our call for an appropriate medium density development. This lead to a meeting of over 200 residents on the 28 October 2013, attended by our State MP, the Mayor of Willoughby, the WCC Director of Planning, several Willoughby Councillors and representatives from several Willoughby City Progress Associations. During the meeting the Mayor and Ms Berejiklian both spoke strongly in support of WCC's alternative proposal the meeting adopted a four-point unamous resolution, with which you will now be familiar, to be put to the Planning Assessment Commission.

While I support the resolution in principal I hasten to emphasise my belief that Council's proposal should be regarded as conceptual only and not a footprint for site development based as it is largely on that set by Channel 9. A proposal incorporating 300 dwellings and eight-storey building heights might require a complete re-think in site planning. For optimum development the layout might have to change.

Mr Haddad, I urge you in your report to the PAC to recommend adoption of the Willoughby Council's development limitations and ask you, Madam Chair, to influence the developer towards that end.

I wish to support the Willoughby Council submission as an appropriate size for the redevelopment of this site. As with others in the community, I support reasonable redevelopment of the site, but object to the proposals by PAC for the number of dwellings and the height of the tower blocks.

The PAC proposals will put unreasonable strain on the local community. I object on the following grounds:

Traffic: Artarmon Road has one lane in each direction. The junction of Willoughby Road and Artarmon Road already sees traffic backed up in peak hours. It is highly likely that Edward Street, Borlaise, Julian and Penkivil Streets will become "rat runs" as drivers seek to avoid the bottleneck.

I support Willoughby Council's proposals as more compatible with dealing with the increased traffic on Artarmon Road, ie in the number of dwellings and therefore vehicles using the site and road; the proposed turning lane from Willoughby Road, and the proposed roundabout in Willoughby Road. I also ask that consideration be given to pedestrians and that pedestrian refuges or traffic lights be installed in Willoughby Road, particularly as school students will be crossing from Willoughby Public and Willoughby Girls' High (after walking along Edward Street).

Transport: The redevelopment will increase transport problems in the area both for the residents and the local community. To reach the city bus in Willoughby Road, residents will need to negotiate a steep hill. As a local resident, I seldom see older people walking up this hill. Local residents wishing to access the railway at Artarmon currently have to walk the considerable distance as we lack a bus service running along Artarmon Road to the station. I would support any proposal by the Council on the provision of a bus service along Artarmon Road, at least in peak hours. This will give access to transport to older residents, and also possibly reduce the impact of traffic on Artarmon Road.

Schools: Local schools are already under great stress with the increased number of enrolments that already exist. The redevelopment, even with the Willoughby Council target number of dwellings, will place additional strain - the PAC proposals, impossible strain. My grandchildren, who live in North Willoughby, are due to attend Willoughby Public School, the first of them next year. The proposals for additional rooms in Artarmon Public, Mowbray Road, and the few additional rooms at Chatswood Public will do very little to help the children in the new homes on the Channel 9 site, or the children already living in the area and attending Willoughby Public.

Height of the towers: I support Council submissions on the height of the proposed tower buildings, on the grounds of overshadowing of local homes, and on the visual impact, particularly from the Artarmon Reserve area as well as surrounding residential streets. The PAC proposals are completely out of sympathy with the surrounding residential and bushland environment.

In summary, I support reasonable redevelopment of the site, and ask only that the proposed redevelopment be scaled to a reasonable size as proposed by Willoughby Council of 300 dwellings and a maximum of eight storeys.
