Re: Request for Additional Information Modification 2 Application MP 08_0260 for Cardinal Freeman Village at 137 Victoria Street, 4-10 Clissold Street and 102-102A Queen St, Ashfield

Reference is made to your emailed request for additional information dated 20 March 2014. We comment as follows.

1. Suggested wording for conditions B17 and B18

On re-reading these conditions it is clear that they mean that contributions can be paid progressively and prior to the issue of a CC for each building. On this basis no change to the conditions is required.

2. Revised Building Perspective

A revised building perspective from the north-eastern edge is contained in Appendix 1.

3. Revised 4th Floor Plan

A revised 4th Floor Plan and Roof Plan are contained in Appendix 2.

4. Reference to Energy Australia

It is suggested that the words *Energy Australia* where ever occurring are replaced with *Supply Authority*. This is because Energy Australia may not be the supply authority.

5. Changes to Project Description

It is suggested that the project description is described as follows reflecting the current modification application.

MP08_0245 concept plan:

The comprehensive redevelopment of an existing retirement village over 2 stages including 7 residential buildings of 3 to 5 storeys in height and a residential aged care facility with associated landscaping, community facilities, internal road network and parking.
