DSC has relieved the Consequential EIA for the Retracted Mine Plan for Drayton South. The original mine plan impacted the Liddell Notification Area surrounding the Liddell Cooling Water Dam and also the Houston Notification Area which is placed around the proposed Houston Water Dam for the Drayton South Project. The impact of the newly retracted mine plan is that the proposed mining no longer impacts any Notification Areas and consequently the Mine will not be required to submit applications to the DSC.
