difficulties and this absolutely affected their racing ability. There is now no oilseed rape grown!

It is, therefore, ridiculous to suggest that raising a foal alongside a coal mine would have no detrimental effect on its long-term future as a racehorse.

To continue coal mining in the Hunter Valley would mean a blight on the landscape and prejudice the Hunter Valley as the centre of excellence for the Thoroughbred Industry.

Could Governments with such an international asset in their jurisdictions and true lovers of the Bloodstock Industry ever live with themselves if this happened and they had to explain to the next generation as to how coal mines were allowed to blot out and clog up the heart of the Australian Breeding Industry?

This cannot be allowed to happen and Juddmonte Farms give their full and unequivocal support to Darley and Coolmore in preventing such a tragedy to happen.

We wish them well and are quite certain common sense will and has to prevail. We trust that Government's will make the right decision to reject the Anglo American mine proposal and protect the Hunter Valley's Thoroughbred Industry.
