## Hi Matthew,

As discussed over the phone yesterday, Roads and Maritime Services has received a Landscape plan for review and approval from a consultant for public domain works to Roads and Maritime Services owned land fronting the development at 5 Whiteside Street, North Ryde. Roads and Maritime Services did not support any improvements on the Roads and Maritime Services owned land. In Roads and Maritime Services letter dated 25 August 2011 it was stated that Access is denied across the Country Road reservation which abuts the subject site, this condition is reflected in the Department's terms of approval A8. However, condition 8 (b) Public Domain states: *The landscape embellishment of RMS owned land fronting Epping Road. The design shall be prepared in consultation with RMS. Any proposal shall not compromise the site's access or be a maintenance issue for the RMS.* Roads and Maritime Services does not support any landscaping works on this site and does not support any pedestrian pathways through this land to access Epping Road. Roads and Maritime Services would prefer this part of the condition is removed. The denial of access is based on a standard notation in relation to a road deviation, that protects the future road corridor and appropriate access points.
