I have been passionate about the development of Barangaroo since attending the first meetings in the Customs House. Crown has asked for a huge increase in floor space, a vast increase in height for three mega towers of \$\$millions++ apartments, and hundreds more car spaces. This greatly diminishes the Public domain, dominates our iconic Harbourscape, and critically compromises the integrity and amenity of Sydney. Buildings can stand for 100+++ years so we must get this right! This grossly bulked-up proposal must be scaled down.

2: After we were told of the Crown plan the Murray Committee was appointed by our former Premier to examine the benefits to the people of NSW...later the Committee report was found to be possibly flawed. Instead of revenue coming into the NSW coffers reputable financial sources said the taxpayers could have losses of many
