RE: Exhibition of a Section 75W Modification Application – Shepherd's Bay, Meadowbank and Ryde (MP 09\_0216 MOD 2)

Dear Mr Lusher,

Thank you for notifying Sydney Water of the modifications to the development listed above. We have reviewed the application and provide the following comments for your consideration.

Sydney Water has no objection to the increased yield of 43 dwellings as proposed in this Section 75W modification. The increased yield has been noted by Sydney Water for use in our detailed planning for works to increase capacity of Sewage Pumping Station (SPS) 105, which has been impacted by the development at Shepherd's Bay.

# Water and Wastewater Servicing

- The existing water and wastewater system will require amplification to service the ultimate development of all stages of the Shepherd's Bay Urban Renewal Area.
- Sydney Water has previously advised the developer of the need to amplify the 100mm main in Narcarrow Avenue to a 200mm main to comply with the Water Supply Code of Australia, due to the size and scale of the development.
- The proposed development impacts on a 400mm trunk main and Sewage Pumping Station 105. Detailed investigation has commenced into identifying the preferred servicing option to service the proposed development in the catchment into the future.

## **Sydney Water Servicing**

A Section 73 Compliance Certificate under the Sydney Water Act 1994 must be obtained from Sydney Water.

Make an early application for the certificate, as there may be water and wastewater pipes to be built that can take some time. This can also impact on other services and buildings, driveways or landscape designs.

## **Building Plan Approval**

You must have your building plans stamped and approved before any construction is commenced. Approval is needed because construction/building works may affect Sydney Water's assets (e.g. Water, sewer and stormwater mains).
