Re: Review of Contamination from Past Agricultural Activities (Banana Growing) 740-742 Pacific Highway Coffs Harbour NSW.

The NSW Department of Planning has received submissions regarding the future development of land identified as *Residential and Tourist Development (Sapphire Beach Resort)* 740-742 *Pacific Highway Coffs Harbour NSW.* A submission was received from Coffs Harbour City Council regarding the possible past land usage and the potential for contamination activities conducted on the Site. Coffs Harbour City Council recognised that the area of the proposed development had potential for banana growing to have been conducted in the past and therefore possible contamination form arsenic, lead and pesticides residues used extensively in banana cultivation.

We have reviewed Coffs Harbour City Council Policy and Guidelines for the environmental assessment of potential and past landuses associated with agricultural activities, more specifically banana growing. These include Councils *Agricultural Residue Policy* and reference to the NSW EPA document *Contaminated Sites* "Guidelines for Assessing Banana Plantation Sites".

David Lane Associates conducted a Phase 1 Preliminary Site Environmental Assessment of the Site in March 2006 to outline the potential for contamination associated with past and present landuses. This study included historical research by way of aerial photographs etc. to determine any past landuses that may have impacted on the soil conditions. The historical review highlighted between 1954 and 1964 farmland (possible banana plantation) was evident in the western (upper) area of the Site with two (2) structures evident in the central area.

As a consequence of the review, and within the limitations of the Phase 1 Preliminary Environmental Assessment, David Lane Associates included appropriate sampling to identify potential impacts. Contaminants of Concern such as arsenic, lead and pesticides (dieldrin, aldrin DDT etc) were included in the analytical suite.

The Preliminary Environments Assessment contained three (3) sample locations within the western area with two (2) specifically in the northern portion of the western area. These were identified as BH1, BH4 and HS1, BH1 and HS1 being in the northern area.

The analytical results from these sample locations are included in the Table below:

The results obtained from the preliminary environmental assessment indicate compliance with the requirements for disturbed terrains associated with past banana growing activities. As such David Lane Associates concluded that the land was suitable for its intended use to a level consistent with Table 5a NEPM 1999 Column A *Residential with Gardens and Accessible Soils.*
