## Hi Matthew,

Roads and Maritime has reviewed the proponent's response to RMS submission (attached) and does not support the proposed recommendations as outlines in point 1 and point 2 of the response. Roads and Maritime provides the following comments/requirements for your consideration:

- 1. Roads and Maritime requires clarification regarding the "<u>the relevant</u> Construction Certificate" as recommended in the point 1. The proponent should specify what they mean by "the relevant".
- 2. Roads and Maritime does not support the recommended amendment with regard to the signalisation of the intersection of Bowden Street/Constitution Road in point 2 of the response. Roads and Maritime requires to ensure the timely implementation of the signals at this intersection and the intersection is to be signalised prior to the release of an Occupancy Certificate for Stage 3 of the development.
