I object to the proposal on exhibition which seeks to make a further application by Johnson Property Group (JPG) to develop a helipad on Lake Macquarie ≜at Bardens Bay adjacent to the marina under construction.

An earlier application for a similar helipad was refused by the planning authority. I OBJECT for these reasons:

1. NOISE POLLUTION ISSUE.

I witnessed the acoustic testing in March this year, so I can appreciate the threat it poses to any semblance of a peaceful existence for residents lakeside if this helipad is approved. The noise was horrendous and an unacceptable intrusion into any expectation of enjoying a peaceful existence. JPG expect the local residents to experience this **eight times daily.** Additionally a two person single engine helicopter was used for the test and the intention for the future is to use a two engine machine carrying more passengers and luggage. This must result in a greater degree of noise than that recorded during the testing. We note that **JPG is not prepared to locate the facility on the extensive land they occupy at Trinity Point. Obviously that would impact adversely on their guests and residents!!**

2. LARGE AREA OF LAKE NO LONGER AVAILABLE FOR PUBLIC USE

An area 9600 square metres of the lake (Crown Land) will be declared off limits and reserved solely for the use of the landing process. This area will be no longer accessible for fishing, boating and other recreational uses by the local community. It will be reserved for the commercial interest of the developer JPG.

3. DISTURBANCE TO WILDLIFE WHOSE HOME IS IN BARDENS BAY.

This area of the Lake, Bardens Bay, has been home to a colony of black swans at least 30, numerous ducks and visiting pelicans. A pair of sea eagles nest nearby. The constant noise generated by regular helicopter activity will drive these creatures away permanently Another blow to the natural environment.

The fish presently living in our bay and available for recreational fishing will surely leave with the constant turbulence to the water generated by the helicopter activity. The natural sea grasses that support the bird life and fish will be adversely affected. **We must protect our flora and fauna.**

4. AVAILABILITY OF AN ALTERNATE FACILITY AT BELMONT AIRPOR

Belmont airport is 15 minutes away by boat and has landing facilities available. Warnervale airport is another option and is about 30 minutes driving distance away. **Either of these facilities could be utilised by JPG.**

Finally I restate my strong objection to the proposal. I join the Morisset Park & District Action Group in its opposition and I support its in-depth submission on this matter.
