# 1. Executive Summary

# 1.1 Summary

Broad stakeholder consultation is required and a plan established by the Aboriginal Housing Company (AHC). The AHC has proactively engaged with the Redfern Community and numerous community organisations that support the Redfern Community.

In response to the Secretary's Environmental Assessment Requirement – SEAR [22 December 2016] the enclosed report addresses the specific requirement relating to Consultation for the Pemulwuy Mixed Use Project in Redfern, Sydney.

Scott Carver Pty Limited were engaged by the AHC in December 2016 to develop and implement a Consultation Plan to satisfy the requirements of the SEAR and to inform the range of stakeholders and community of the modifications relating specifically to the Student Housing – Precinct 3 as per the proposal submitted to the Department of Planning – W75 Application in October 2016, and advancement of the design through the Design Excellence process.

Further to this on 03 May 2017 Modification 2 of the SEAR's was issued by Department of Planning [DoP] as a response to further advancement through the Design Excellence Review Panel [DERP] for an architectural design [23 story], public domain and Public Art Framework.

The Consultation Program adopts a multi engagement approach;

- Aboriginal & Torres Strait Islander Community;
- Redfern and Local Community; resident and business;
- Community Groups & Organisations; and
- Government & Key Stakeholders

# **Project Drivers**

The proposed model for the Pemulwuy Project allows the AHC to finally unlock the true potential of the land for the benefit of the Aboriginal & Torres Strait Islander People and the Redfern Community.

The proposed model allows the AHC to achieve all of its core objectives.

- The AHC to remain the legal owners and custodians of all of the Pemulwuy land forever.
- The AHC to deliver on its mission 'to provide affordable housing to Aboriginal & Torres Strait Islanders'



- AHC to be financially independent, creating a sustainable future for generations
- A new era of self-determination for the AHC
- The AHC to deliver the affordable housing and commercial and retail precincts at the same time as the student accommodation.

## Proposition - Modification 1 to Student Accommodation

Specifically the modification to the Approved Concept Plan in relation to Precinct 3 to:

- Increase minimum building height from 6 to 16 storeys;
- Increase gross floor area (GFA) from 6,462m2 to 17,080m2;
- Increase floor space ration (FSR) from 2.9:1 to 7.6:1 and
- Increase student accommodation room from 154 to 522.

## Proposition - Modification 2 to Student Accommodation

Specifically the modification to the Approved Concept Plan in relation to Precinct 3 to:

• Increase minimum building height from 16 to 23 storeys of student accommodation, under the guidance of DERP, was considered to be the optimum urban design outcome. The minutes from DERP meetings and report is subject to a separate submission directly to the DoP.

## Process

To ensure a transparent consultation program was implemented a co-ordinated and paralleled approach was required:

- Consultation Plan engagement
- Design Excellence Design Excellence Review Panel [DERP] design quality
- Media Plan communication

The Design Excellence Process is a requirement of the DoP in response to concerns raised by the City of Sydney Council as the proposed modifications to the Approved Concept Plan was outside of the planning code. A Design Excellence process was initiated in January 2017. The architectural design development, as per Meeting No.4, was the basis of the community presentation, noting that the architecture and public domain was further evolved post the Community Event [Meetings 5 & 6].

The result of the Design Excellence Process, Meetings 5 & 6, was to re-model the architecture and include additional storeys to the building. This induced a further Public Consultation Process which was carried out by both Press Release and a direct mail out to the Community. This secondary process of consultation was agreed with the Department of Planning prior to its execution.



## Delivery

The Consultation Plan has been delivered in three [3] parts over a six month program commencing in late December 2016;

- Part 1 Consultation; Pre Planning, Government and Empowered Community
- Part 2 Community Information Event [09 March 2017]
- Part 3 Post Event Consultation & Feedback

This Community Event explained the proposed 99-year lease transaction with Atira and financial model to seek community feedback on that transaction as one of the key drivers of the modification to the Student Accommodation proposition.

## Reporting

This report details the actions of the consultation, objectives, process and evidence to support the SEAR requirements.

## Outcome

The Pemulwuy Precinct 3 – Modification to Student Accommodation has embraced a parallel design excellence and consultative process. The community interests are diverse and are founded in a 40 year history associated with the Pemulwuy site.

The consultative process has offered opportunity for the local community, Community Organisations and NGO's and agency stakeholders to participate in the proposed modifications and ample opportunity to provide feedback though hard and digital formats. Additionally, a media campaign has added in discriminating information to the broader community and to seek their feedback.

In total twelve [12] formal feedback responses were received, six responses each for the 16 storey and 23 storey propositions by the AHC and or Scott Carver. These are contained in the report appendices for reference.

We conclude that there is majority support for the Aboriginal Housing Company objects and proposed development model to be delivered as one project inclusive of Precincts 1 through 3



# 2. Pemulwuy Mixed Use Consultation – Modification to Student Housing

# 2.1 The Student Accommodation Proposal

The Aboriginal Housing Company [AHC] has sought to modify its 2012 Concept Plan consent to increase the student housing component in Precinct 3 with an application in October 2016 to the Department of Planning.

It is important to note that the modification only relates to Precinct 3 – Student Housing and that the Affordable Housing (Precinct 1) and Commercial and Child Care (Precinct 2) remain as per the 2012 consent. The intent of the public domain will be incorporated to suit the agreed architectural direction established with the Design Excellence Panel.

It is intended that all three precincts will be delivered concurrently by January 2019.

## Key Messages

# The proposed model for the Pemulwuy Project allows the AHC to finally unlock the true potential of the land for the benefit of the Aboriginal & Torres Strait Islander People and the Redfern community.

Set out below are the key messages that will inform all communications to stakeholder groups in meetings, written communications, speeches and presentations.

The proposed model allows the AHC to achieve all of its core objectives – other models that were considered did not achieve all of AHC's objectives.

- The AHC will grant Atira a commercial 99-year lease for the development of part of the Pemulwuy land for student accommodation (Precinct 3)
- This land has been approved exclusively for use as student accommodation since 2012
- The AHC will use the funds from the 99 year-lease to develop Precinct 1 the 62 dwellings for Aboriginal & Torres Strait Islander people AND Precinct 2 the commercial and retail space.
- The AHC will retain operational control of Precincts 1 and 2.
- Atira will maintain operational control of Precinct 3 student accommodation.

# The proposed model allows the AHC to remain the legal owners and custodians of all of the Pemulwuy land forever.

- The AHC has granted a 99-year lease to Atira only in respect of Precinct 3, so that Atira can develop student accommodation on that part of the land and at the expiry of the lease, any improvements on the land will belong to the AHC.
- A lease is not a sale and the AHC remains at all times the sole legal owner of the land Pemulwuy staying in Aboriginal hands forever



- A 99-year lease provides financial security and certainty for the future for the AHC and its constituents.
- The AHC will be able to unlock the true potential of the land for the benefit of Aboriginal & Torres Strait Islander people and the wider Redfern community.

The proposed model allows the AHC to deliver on its mission 'to provide affordable housing to Aboriginal & Torres Strait Islanders'

- 62 dwellings will be built for Aboriginal & Torres Strait Islander families, designed to provide housing for families through generations.
- Student accommodation precinct will address a market shortage of student rooms in Sydney
- The entire community will benefit from retail and cultural centres and employment opportunities
- Local businesses (including future retail/commercial tenants for Precinct 2) will benefit from the addition of more than 500 students moving into the local area.
- The Pemulwuy Project will be a meeting place to welcome all members of community and provide learnings about indigenous cultural heritage lead by the AHC.

#### The proposed model enables the AHC to be debt free, creating a sustainable future for generations

- Because the AHC is granting a 99-year lease, the AHC does not need to borrow money in order to develop the affordable housing.
- The AHC will not create a legacy of debt that will burden future generations.
- The AHC will have a strong and certain future as a result.

#### The proposed model marks a new era of self-determination for the AHC

- The Pemulwuy Project marks a new era for the AHC
- The AHC decides how the land is used and is responsible for the project
- The AHC's Pemulwuy Project will create history as the first of its kind for the AHC and for any indigenous organisation in Australia – creating a new model and leading the way for similar projects around the country.
- The AHC's Pemulwuy Project will be managed by the AHC.
- The AHC's Pemulwuy Project will not need to rely on government funding.

# The proposed model allows the AHC to deliver the affordable housing and commercial and retail precincts at the same time as the student accommodation.

- The Pemulwuy project will be a one build program delivered by Deicorp who has been selected by AHC to deliver the entire project.
- The AHC will not have to wait to build its affordable housing all precincts will be started at the same time and it is expected that the affordable housing will be completed first.



# 2.2 Consultation Objectives

The consultation program is designed to ensure that key stakeholder groups, business and resident community have the opportunity to attend a formal community information session. The objective is to promote the exchange of information, and to understand the views of the community and stakeholders.

Specific objectives were to:

- Ensure the consultation process provided the community with access to relevant information about the proposed project;
- Ensure members of community, including Aboriginal residents, had an opportunity to raise issues, questions and concerns, and express their views and comments on the proposed project;
- Provide a mechanism to respond to issues, questions and concerns raised by the community, listen to views expressed, to recorded community positions so as to inform the Department of Planning;
- Develop consultation processes that helped to counter any misinformation and/or misunderstanding in the community about the modified student housing proposition, and
- Provide evidence of engagement with relevant Aboriginal stakeholders regarding cultural design elements, including motifs, public art and place and building naming (Item 3 Built Form and Urban Design SEAR).

# 2.3 Process

To ensure the requirements of the SEAR (22 December 2016) are fulfilled a number of elements needed to be delivered in parallel to inform the Community Information Event on 9th March 2017 at the Redfern Community Centre.

The Consultation program is designed to ensure that key stakeholder groups, business and resident community have an opportunity to attend a formal community information session. The objective is to promote the exchange of information, engage the community in the vision for the project and to ensure understanding of the views of the community and stakeholders.





# 2.4 Design Excellence Review Panel [DERP]

A requirement of the SEAR is that the proposal must demonstrate design excellence.

The Design Excellence Process was put in place by the DoP in response to concerns raised by the City of Sydney Council. The Design Excellence Process was initiated in January 2017 culminating in a Community Event to be held on 9 March at the Redfern Community Centre and further architectural | public domain integration in April | May 2017 (meetings 5 & 6].

The architectural design direction of the modified Student Accommodation was included in the Community Information Event presentation [16 storey scheme] to inform the community of the context, bulk, scale and form of the built form, as agreed by the DERP, and presented by TURNER architects. Further consultation was implemented on the 23 Storey proposition, as requested by the DoP, in May | June 2017.

Minutes of the Design Excellence Panels are subject to a different reporting process.



# 2.5 Media Alignment

A media strategy is not required under the SEARS, however was considered important by the AHC to ensure that all members of the community were provided the same information, there multimedia communication are employed and to avoid misinformation.

## Media Communication Objectives

For the broader community, stakeholder group and media to clearly understand and support the Pemulwuy project.

- Build awareness and understanding of the community benefits of the Pemulwuy project.
- To communicate the AHC as the Pemulwuy project developer and landowner.
- To communicate a model future development projects on a similar funding structure that will return projects that are without long term debt.
- The AHC has declined a Government grant of \$5million. The AHC has requested this funding to be redistributed into the community.
- To enable the growth of the AHC to provide open opportunities such as a "hand up" home ownership program for the Aboriginal and Torres Strait Islander community.

The media program would extend beyond the Community Information Event as a continuation of communication between the AHC and broader community as the Pemulwuy project gained momentum.

## Project Key Messaging

- The AHC is the sole developer and owner of Pemulwuy. With an independent board, it is self-determined and free of government funding.
- The AHC has financially re-engineered Pemulwuy project; under guidance by KPMG, to ensure it is totally self-funded and debt free, ensuring the financial future of Pemulwuy for all future communities.
- The AHC will grant a 99-year lease on Precinct Three. The leaseholder will be ATIRA, a student-housing provider.
- The Pemulwuy project proposes an increase in the student housing, resulting in a height increase from 6 to 16 storey's. The student housing is a significant part of the project offer and supports NSW Government initiatives to promote new student accommodation and affordable housing in Sydney.



- A project-funding model has been developed to ensure the project doesn't leave a legacy of debt for the community. It will be totally self-funded
- The AHC seeks to unlock the full potential of the land to maximise social inclusion by creating additional housing for all students, and to maximise all social benefits of the site – including residential, cultural and commercial purposes.



# 3. Consultation Program

# 3.1 Stakeholder Consultations

The Consultation Plan is to be delivered in three [3] parts over a four month program commencing in January 2017;

- Part 1 Consultation; Pre Planning, Government and Empowered Community
- Part 2 Community Information Event [09 March 2017]

  - 3B 23 storey proposition [May | June 2017

The Consultation Program adopts a multi-stakeholder and multi-channel approach;

- Aboriginal Community;
- Redfern and Local Community; resident and business;
- Community Groups & Organisations; and
- Government & Key Stakeholders.

# 3.2 Aboriginal & Torres Strait Islander Community

The AHC has been actively engaged with the Aboriginal & Torres Strait Islander community which has also been engaged in the implementation of their Social Plan. Additionally, the Aboriginal community were invited as participants in Community Information Session to further inform them of the proposed development.

So as to not preference or exclude any indigenous group or representative organisation, a single invitation was extended to the Aboriginal Community. A flyer notification was also provided to addresses in Redfern, Ultimo and Zetland.

# 3.3 Redfern and Local Community

A flyer invitation was distributed to 6500+ premises in Redfern, Ultimo and Zetland. In addition community notices and media were used notify of the Community Information Event. Letters of invitation were sent to;

# 3.5 Government & Key Stakeholders

The Aboriginal Housing Company, with their appointed Development Manager (DeiCorp P/L), has pursued a proactive approach to liaison with the respective key stakeholders in relation to this development.

A number of key stakeholders; The Government Architects Office and Department of Planning are represented on the Design Excellence Panel to advance the building proposition for Precinct 3 – Modified Student Housing.

# Consultation

Scott Carver confirms that all of the above parties have been directly engaged through formal meetings and all received letter invitations to attend the Community Information Event and post event information.

The majority of agencies advised that they would respond directly to the DoP through the referral process. As mentioned, the DoP and Government Architects Office were integral with the Design Excellence process.



# 4. Pre Planning and Key Engagement

Pre planning for the information event commenced in January 2017. The Redfern Community Centre is the venue for the event to be held on 09 March 2017, 7.00pm-8.30pm.

The AHC and consultant team engaged with Government and Agencies to inform them of the Consultation Program and issues of specific relevance to the party, noting that the architectural product was been developed in parallel with the Design Excellence Panel.

Key consultation was conducted with the AHC Board and Empowered Aboriginal Community in advance of the Community Information Event. Media releases were issued including notification of the Community Information Event.

## **Table of Consultations Pre-March 9 Community Event**



The AHC commenced the process of consulting with key stakeholders and influencers ahead of the Community Event on 9 March:

- AHC took its member families through the proposed transaction (including the 99-year leasehold structure) at its AGM in February 2017. There were no objections raised at this time and the member families were overwhelmingly supportive of the transaction.
- AHC has engaged directly with Empowered Communities via a face to face meeting. Empowered Communities <a href="http://empoweredcommunities.org.au/">http://empoweredcommunities.org.au/</a> is a very high-profile and influential group of respected leaders from Aboriginal communities around Australia. Constituents from urban, regional and remote parts of the country are represented by 8 nominated indigenous community leaders who have set a collective vision to work collaboratively with both government and corporate Australia to reform how Indigenous policies and programs are designed and delivered. Empowered Communities represents a very broad range of indigenous people from around Australia. Empowered Communities are strongly supportive of the transaction and see this project as a benchmark / new model for the sustainable delivery of affordable housing for urban and non-urban indigenous communities around Australia. AHC is seeking a letter of support from Empowered Communities as part of the formal community engagement and feedback process.
- Government AHC and its advisors (Scott Carver and Deicorp) have engaged with relevant government departments that are required to provide feedback to the DoP as part of the planning process. Importantly, concerns raised by City of Sydney regarding design elements of the project have been addressed by the Design Excellence Process that is being undertaken (part of which is the community event on 9<sup>th</sup> March).

## **Community Feedback Documentation**

To properly and consistently identify the feedback and views of the Aboriginal & Torres Strait Islander and broader community and stakeholder groups, meetings are minuted and supporting letters and or communications provided to evidence the process.

A Feedback Form was distributed at the Community Event and post event via AHC online web-link [refer appendix 8.1]

In order to allow respondents an opportunity to provide detailed, honest and unconstrained feedback, the Feedback Form are prepared in a free-text format. This ensures that we receive non biased feedback by 'leading questions' or constrained by a certain format.

Feedback will be captured via the following channels; face to face meetings, via email responses, verbally via the Aboriginal Housing Company and Scott Carver and hard copy Feedback Form via post or drop-off box.



# 5. Community Information Event

The Redfern Community Centre is the venue for the event to be held on 09 March 2017, 7.00pm-8.30pm. The venue is selected as a central location and accessible by public transport in the heart of the Redfern Community.

A combination of letter, media, posters and letter drop were used to inform the community and stakeholders of the event. A pre registration process was facilitated by Scott Carver, on behalf of the AHC.

The event was conducted on the 09 Mach 2017 with 156 signed in participants. A structured presentation format was adopted in two parts;

- Information
- Q&A session

The presentation is included for reference in Appendix 8.1

## **Proceedings Summary**

Formal proceedings commenced at 7.00pm sharp with facilitator introductions, agenda and protocols communicated to the meeting. Following a "Welcome to Country" the Aboriginal Housing Company - CEO deliver the project context, objectives and funding model to enable the whole project to be delivered concurrently, founded on the uplift proposition of the Student Accommodation from 154 rooms to 522.

Thirty minutes into the presentation, a minority group set about to disrupted proceeding with verbal interruption and verbal attacks on presenters. The AHC in consultation with the Redfern Police Commander (present in the audience) halted the presentation and closed the meeting at 7.45pm. The full presentation on the architectural proposition, further detail on the Student Housing management model and the Q&A session **could not** be delivered to the majority of the community attending the meeting.

The disruption to the Community Information session was a premeditated act by a minority [4-6 persons] that disadvantaged the majority of meeting attendees who there to understand the Student Housing modification and participate in a Q & A session forum.

# 7. Consultation Summary

# The majority of submissions were supportive of the proposition and AHC objectives for a self sustaining development.

The AHC has delivered a Consultation Plan that allows key stakeholders and the community to respond in an equitable way that captures different views. This ensures that AHC receives accurate and consistent feedback that will provide an insight into the critical issues and the level of support.

A three part process has been delivered to a four month program [January – April 2017]

## Feedback

## 3A 16 Storey proposition.

• Six [6] formal Feedback Forms or letters were received from the Community [Refer Appendix 8.3].

## 3B 23 Storey proposition.

• Six [6] digital Feedback Forms were received from the Community [Refer Appendix 8.4].

## Key Issues

- Majority support for the AHC objectives and financial independence model
- Only two respondents made comment received on the architectural uplift proposition
- Support for delivery of Precincts 1-3 concurrently.

Of note was a letter received from Lisa De Luca & Co – Solicitors that was responded to directly by the CEO of The Aboriginal Housing Company to clarify and refute statements in the letter and to direct where additional information could be accessed regarding the full presentation at the Community Information Event. The letter and AHC response are provided for the record.

The Community Event was video recorded for the record and is available upon request from the AHC.

## Public Art Framework - Engagement

Provide evidence of engagement with relevant Aboriginal stakeholders regarding cultural design elements, including motifs, public art and place and building naming (Item 3 – Built Form and Urban Design SEAR).



The AHC has agreed an appropriate process for the Public Art strategy, design and procurement which is further detailed in the Public Domain Report [Scott Carver]. The 2012 Development Consent provides the basis of the elements that were defined in consultation with the Aboriginal Community by the AHC.

At the recommendation of the Design Excellence Review Panel, Professor Michael Tawa (University of Sydney) was engaged to provide strategic guidance with the AHC and Scott Carver to further develop the story and brief definition for the artworks to capture PEMULWUY as an extension of "Country" with reference to the land and people [past and present].

Underpinning the Public Art Framework is education for the future generations – stories of the land. Three elements are identified in the public domain and three specific elements associated with each of the three development precincts;

## Themes

## **Public Domain**

- Precinct 1 Landscape Ancient Australian Flora
- Precinct 2 Aboriginal Flag sculptural element urban connection to land
- Precinct 3 Urban Art 'Living Canvas' Wall integration

## **Precinct Elements**

- Precinct 1 The Meeting Place Pemulwuy brand logo
- Precinct 2 Hands of Reconciliation
- Precinct 2 Wall of Nations [childcare]
- Precinct 3 Building Soffit architectural element Galaxy Dreaming

To date there has been initial discussions with local indigenous artists and Professor Tawa on the elements and approach. The ongoing direction will be to;

- Public Art Framework
- Elements brief
- Identification of artist and key consultant participants
- Element procurement
- Implementation.

Upon formal adoption of the Public Art Framework, the AHC it will implement the elements to meet the completion of the project in 2019.

# Indigenous program offers introduction to university life

THE University of Sydney was founded on the principle that it would offer "the opportunity for the child of every class to become great and useful in the destinies of his [sic] country" (William Charles Wentworth).

It was a fine, and indeed, progressive aspiration in 1850, and it is one that the University follows today - although now we would say "his or her country", of course. Despite his remarkable liberalism, Wentworth did not imagine a time when women would be admitted on an equal footing with men, although this was in fact only a few years away.

We do more than just open our doors to those who meet our requirements. The University runs many programs to introduce schoolchildren and others to our campus, so that they may understand how they, too, could

become students here one day. We want everyone to feel welcome, and we want all Australian children to feel that they could achieve their dreams by studying at the University of Sydney.

This year is the fifth in which we have run the Wingara Mura-Bunga Barrabugu program, designed to give Aboriginal and Torres Strait Islander schoolchildren a taste of university life. More than 200 high school students from as far afield as Thursday Island, Badu Island, and Karawara spent a week here

in January, staying on campus and taking part in a series of academic and cultural events. Ranging from years 9 to 12, they explored different subjects and options for university study and their future careers and learnt useful skills to equip them for their final years at school.

They toured an aerospace laboratory equipped with flight simulators and drones, wrote and recorded music at the Sydney Conservatorium of Music, attended a hands-on marine biology workshop at the Institute of Marine Science

## TO ATTENDEES OF THE COMMUNITY CONSULTATION EVENING

Thank you for taking the time to attend last week's community consultation evening for The Pemulwuy Project in Redfern. The Aboriginal Housing Company (AHC) is proud to have brought together over 150 members of the community to discuss the future of the project.

As the event was closed early, only part of the information was presented to the community, so we would like to take this opportunity to share with you our presentation in full.

Our aim was to inform the community as a whole about our plans and key objectives for the development.

As was presented on the evening, the AHC has sought advice from tier one accounting firm, KPMG on our new funding model for The Pemulwuy Project, which will allow us to deliver on our core objectives:

- To deliver quality affordable housing to the Aboriginal and Torres Strait Islander community
- To retain full ownership and control of the site
- To create history for the Aboriginal and Torres Strait Islander people through a new era of self-determination
- By delivering this project to the community with no financial burden to our future generation. This means that they too can maintain long-term financial independence.

As you heard last week, the new funding model means that we have had to modify the existing DA, amending the number of student accommodation from 154 to 522 rooms and the height of the building from 6 storeys to 16. This will allow the AHC to unlock the value of the land.

This will see the AHC grant a 99-year lease to student accommodation provider Atira, who will pay the lease up front. This income will allow the AHC to fully fund the development of Precincts 1 and 2 – allowing us to build and deliver 62 affordable housing for our Aboriginal and Torres Strait Islander community first.

The AHC will be implementing opportunities for employment, education and apprenticeships. We are also looking forward to leading the cultural heritage education for the Pemulwuy Project as part of student life.

There were crossed wires on the "imaginary/imaginative" point, from original statement by Bryant, which I believe was clarified at end of meeting with

some. This referred to the development, not the originators. However that led to Lyall getting up and speaking, which in the way it was handled turned out to be a plus.

## LYALL

His statement about being a "founder' was positive – and Mick letting it run – I believe cooled things down for a while.

It was very well handled.

The founder point may need to be followed up.

## RE: Aboriginal Housing Company ("the AHC") and the Pemulwuy Project Meeting At Redfern Community Centre on 9<sup>th</sup> March 2017

We act on behalf of the Redfern Aboriginal Tent Embassy and a number of concerned Aboriginal elders in the Redfern community.

We refer to the meeting held on 9<sup>th</sup> March 2017 and understand you are the company engaged to promote the Pemulwuy Project.

Putting aside the many concerns with the proposed development for the moment, and with specific reference to the meeting on 9<sup>th</sup> March 2017, we draw your attention to a number of issues:

- 1. That there was an obligatory signing on of attendees, when what they were actually signing was not an attendance sheet, but in fact a waiver and release;
- 2. That the manner in which the meeting was conducted was in complete breach of Aboriginal protocols. On several occasions, when an elder rose to speak, they were continuously spoken over; menaced, told to shut up, be quiet and sit down, and a microphone was at one stage turned off on Mr Lyall Munro as he was speaking. Mr Munro is the only surviving member of the Board who went to Canberra to lobby the Whitlam Government and secure the original grant of money for the land now known as The Block;

- 3. The hurt and dismay felt by many Aboriginal people in the audience at how they had been treated on the night;
- 4. The fact that no "consultation" or dissenting community views were permitted at all on the night;
- 5. That a non-Aboriginal woman, Ms Tuitavake from the Aboriginal Housing Company, was permitted to speak on behalf of the Aboriginal community;
- 6. That you failed to provide a safe space for attendees. During the meeting, several threats were made to dissenting female elders in the audience by two males linked to the Aboriginal Housing Company;
- 7. That during the meeting, one female community member was assaulted in full view of attendees by the daughter of Michael Mundine, CEO of the Aboriginal Housing Company. Violence perpetrated by people linked to the AHC against dissenting voices in the community has a long and shameful history;
- 8. The visual presentation contained material which had typographical errors or which did not accord with what was being verbally represented. On many occasions, the audience requested that the slides containing the information remain on view longer. These requests were ignored;
- 9. Above all, that this "consultation" meeting will be the extent of your consultation with the community, or that future consultation will only target those parts of the community which do not dissent or oppose the development.

We ask you the following questions:

- A. May we please have a hard copy of the visual presentation made by Scott Carver to the audience on 9<sup>th</sup> March 2017?
- B. Does the meeting on 9<sup>th</sup> March 2017 constitute the only "community consultation" in respect of the Pemulwuy development?
- C. If so, does this mean that the time for lodgment of any objections to Council runs from 9<sup>th</sup> March 2017?
- D. If not, how and when will you conduct a future community consultation?
- E. May we please have a copy of the Development Application and proposed Plans? It is a concern that they are not on the City of Sydney Council website as yet.
- F. May we please have a copy of the proposed agreement/lease arrangements with ATIRA?

We have been asked to respond to your letter of 15 March, 2017 addressed to the firm, Scott Carver Pty Ltd, who were contracted to organise and facilitate the public consultation for the Aboriginal Housing Company's (AHC) Pemulwuy Project. Scott Carver Pty Ltd are not 'promoters' of the project.

We note you act for the Redfern Aboriginal Tent Embassy and a number of Aboriginal Elders of the Redfern community. We are not sure of the status or nature of the Embassy, however it may assist if we reply to the matters raised in your letter.

1. There was no obligatory signing on of attendees.

There were two registers at the entrance to the meeting. One was an attendees register, with no conditions, which people attending where requested to sign. There was also a register, provided by Scott Carver, which people could sign, if they wished. This advised the event was being recorded and stated people signing this document consented to the recording being made.

2. The meeting was called to inform members of the community of the particulars of the Pemulwuy Project, including the new student housing proposal. It was intended there be a question and answer session after the Project was explained.

At the beginning of the meeting the Chairperson was able to provide an overview of the Project, including some particulars of the affordable housing for Aboriginal and Torres Strait Islander people, the fact that an Aboriginal organisation would be carrying out the development, without Government financial assistance, self-determination, that there would be no debt established to carry out the development and that it would be a requirement that the building of Precincts 1,2 and 3 would be concurrent. Thereafter, after Lyall Munro spoke, some 3 or 4 people shouted down the speakers, including the General Manager and Andrew Turnbull. No speaker could be heard as a result of the shouting activities of those 3 to 4 persons, so the Chair, properly, closed the meeting.

As a result of the shouting actions of those few persons, the rest of those attending, some 150 persons, were deprived of hearing more particulars of the Project and of the question and answer session.

Lyall Munro, while interrupting a speaker, was allowed to walk up to the front and speak until he finished what he wished to say. We believe the meeting respected him for his unique historical connection to the ' The Block'. As Lyall would know the statement by Minister Gordon Bryant, 15 April, 1973, stated amongst other things, that the grant was 'to finance an imaginative community housing development put forward by Aborigines in Sydney."

3. There was considerable dismay by the majority of attendees that the meeting could not continue as planned and that the informing of the Community was cut short, by the actions of 3 to 4 persons.

4. This observation is untrue. Lyall Munro was allowed to speak. Thereafter the actions of the 3 to 4 persons precluded the vast majority of persons who attended the meeting from being further informed about the Project.

5. The General Manager of AHC spoke on behalf of the company, until she was shouted down, by a small number of attendees, which we believe was not in accordance with any proper protocol, and was very disturbing.

6. The meeting was held at the Redfern Community Centre and a Police Officer was in attendance. We are not aware of any threats being made at the meeting.

7. No assault took place. The Police Officer attending dealt with the intrusion by the 'female community member'.

8. Only a small amount of visual presentation took place as a result of the actions of the 3 to 4 persons. We believe what was shown was accurate.

9. The sole purpose of the meeting was to inform those persons who attended, and the Community generally. Those who dissented on the night, forced the meeting to close early. That is to be regretted.

In regards to proposed development by AHC of the "Design Excellence process for the Student Accommodation precinct of the Pemulwuy Project" Metropolitan Local Aboriginal Land Council as the legislated authority for fostering the best interests of all Aboriginal people of the area we cover that includes Redfern & the Aboriginal Housing Company's proposed development, we make the following comments:

MLALC does not support the "Design Excellence process for the Student Accommodation precinct of the Pemulwuy Project" on the basis of:

1. Aboriginal Housing Company is a private company and apparently attempting to utilise community assets and public land for private benefit as a private company not consistent with its original aims and objectives nor the Commonwealth Governments funding used to purchase the "Block" for the provision of housing for Aboriginal people.

2. AHC is not adhering to funding and grant conditions that it was & has been provided through public money at both Commonwealth and State governments as well as the former Aboriginal & Torres Straight Islander Commission and land its was provided is for community benefits specifically housing for the Aboriginal community not for commercial profit and not non Aboriginal peoples benefits.

3. Concern that the land identified for location of the student accommodation along the rail line was potentially provided by City of Sydney Local Government for a private commercial benefit and land transferred by Murrawina the preschool that was able to purchase land in Eveleigh Street in 1974 to operate a Aboriginal Child Care Centre in Redfern has inspired similar preschools all over Australia to be established but we do not see any plan for it to be returned in the proposal.

The use of public land for private gain is never supported and seemingly contradicts all requirements for use of public land to provide public benefit.

4. AHC is perpetrating a myth that it needs the income from developing private student accommodation to fund Aboriginal Community housing when the Commonwealth government has offered to pay for the Aboriginal Community Housing to be built on the block. Furthermore we are deeply concerned that we are not aware of any undertaking by AHC to ensure only Aboriginal students will receive accommodation benefits from the proposal

5. AHC has undertaken no consultation with the Aboriginal Community on the proposed "Design Excellence process for the Student Accommodation precinct of the Pemulwuy Project".

6. Major concerns at AHC's governance & administrative capability and capacity given its operational history, not being a open Aboriginal Community Controlled organisation by limiting its membership and also the sale of community assets funded by the commonwealth government programs to operate despite having a substantial asset base to manage doe not provide confidence of managing this in the best interests of the Aboriginal community for whom the land was purchased for by the then Whitlam Government.

Metropolitan Local Aboriginal Land Council hopes that the AHC will revisit its draft plans for re development of the block it proposed in late 1990's that was & is a true model of 100% Aboriginal self determination, with 100% Aboriginal residential and commercials activities.

Should you need or require any additional information & or clarification please advise.

## Sydney, Monday 20 February, 2017 – The Aboriginal Housing

<u>Company's</u> (AHC) <u>Pemulwuy Project</u> is one significant step closer to being delivered.

Pemulwuy Project includes three adjacent precincts located between Louis Street and the railway corridor, opposite Redfern train station:

- Precinct 1 will feature affordable housing for Aboriginal and Torres Strait Islander people
- Precinct 2 will feature commercial and retail spaces
- Precinct 3 will feature student accommodation

There will be no changes to the previously DA approved affordable housing and commercial precincts - Precincts 1 and 2. The changes include increasing the number of student accommodation rooms in Precinct 3, which will allow the AHC to fund the entire project on its own.

This new model will enable all three precincts to be delivered in one stage and will ensure the AHC remains debt free and sole legal owners and custodians of the land.

For the proposed model to be viable, the student accommodation precinct will need to increase as follows:

- The building will increase in height from 6 to 16 storeys
- The gross floor area will increase from 2.9:1 to 7.16:1
- The number of rooms for student accommodation will increase from 154 to approximately 522

A SEARS application was submitted to the Department of Planning in 2016 reflecting these changes.

AHC Chairperson, Alisi Tutuila, said, "We are extremely excited about this new model to deliver the Pemulwuy Project in a way that realises our core objectives for our community. We will now be able to deliver the Pemulwuy Project as a whole in one stage, and there will be no changes to the affordable housing solution for Aboriginal and Torres Strait Islander families, which is our core objective."

"This new model will allow the the Pemulwuy Project to remain financially independent and self-determined and the AHC will remain sole legal owners of the land and site custodians. We won't be leaving a legacy of debt for our future generations, which is extremely important to us."



"Our Board has worked tirelessly on this project for many years and we are delighted with this proposed model, which unlocks the true potential and value of the site. It maximises the opportunity for social inclusion by creating affordable housing for Aboriginal & Torres Strait Islander people and important cultural and commercial opportunities."

"Other funding options we explored simply did not allow us to realise all of our objectives: to deliver the Pemulwuy Project in one stage, to provide affordable social housing for our community, to remain legal owners and custodians of the land, and to remain debt free for our future generations. This model is a win win for everyone," she said.

**Sydney, Wednesday 1 March, 2017** – <u>The Aboriginal Housing Company</u> (AHC) is proud to be addressing two very important community needs as part of the <u>Pemulwuy</u> <u>Project</u> in Redfern.

The Pemulwuy Project will be delivering on the AHC's core business objective of providing affordable housing for the Aboriginal and Torres Strait Islander community and provide much needed student accommodation to Sydney.

According to a 2016 study conducted by global real estate firm <u>Knight Frank</u>, Australia is experiencing a significant undersupply of purpose built student accommodation. In NSW, this undersupply of high quality, affordable accommodation is projected to sit between 74,763 and 99,275 much needed student beds by the end of 2020 – and 404,700 nationally.

# **Aboriginal Housing Company Statement**

**Sydney, Thursday 9<sup>th</sup> March, 2017** – The Aboriginal Housing Company (AHC) is committed to delivering The Pemulwuy Project in Redfern and wishes to clarify a number of comments made in recent media articles.

Firstly, the AHC wish to clarify the status of the proposed government grant. The Federal Minister for Indigenous Affair's office proposed a \$5million grant toward The Pemulwuy Project in 2015, which is currently still in negotiation stage.

The proposed \$5million government grant came with a certain number of conditions, which the AHC is already adhering to. The AHC proposed for the grant to be released once a certificate of occupation was obtained at completion of the project. This would minimise the risk on the government.

The AHC has been keeping the Minister's office regularly updated about the status of the project since September 2015, with the most recent meeting with the Minister's advisor late last year, and further correspondence as recently as last week.

The AHC has consistently maintained the above terms for the grant on several occasions with various representatives of the Minister's office.

It is important to note however that a \$5million government grant will not cover the cost of building 62 affordable housing dwellings for the Aboriginal and Torres Strait Islander community, therefore it is imperative that the AHC source alternate funding to ensure that the project remains financially viable, and delivered in one stage.

Secondly, the AHC would like to address comments made by Nathan Moran, CEO of the Metropolitan Local Aboriginal Land Council (MLALC) that the AHC has not consulted the Aboriginal community on changes to The Pemulwuy Project.

As part of the Aboriginal and Torres Strait Islander Community, MLALC have been formally invited to attend the community consultation evening to be held tonight at Redfern Community Centre. It is the intention of the AHC to involve all members of the Redfern community as one, hence this evening's community consultation.

The MLALC has not approached the AHC informing that they would be willing to mortgage their assets to assist in funding The Pemulwuy Project.

The AHC is proud to realise the right to self-determination by making history with the development of the Pemulwuy Project, as the only Aboriginal and Torres Strait Islander group to embark on such a project.

The Pemulwuy Project will be a thriving community of social inclusion. The project will breathe new life into the community and embrace a new platform for the Aboriginal and Torres Strait Islander people. The Pemulwuy Project is a foundation of growth for the community.



This project is just the beginning for the AHC, the proposed funding solution will allow the AHC to deliver, enhance and extend their core business objective of providing affordable housing to the Aboriginal and Torres Strait Islander community far beyond the delivery of The Pemulwuy Project.

# The Pemulwuy Project set to open opportunities for the Aboriginal and Torres Strait Islander community

**Sydney, 27<sup>th</sup> March 2017** – The Aboriginal Housing Company (AHC) unveiled its funding model for the Pemulwuy Project at the community consultation event on 9<sup>th</sup> March 2017. The AHC has emphasized that this model will enable it to fully fund the development of Precincts 1 and 2, and deliver the 62 affordable housing dwellings **first for the community.** 

The AHC's ambition is to create a positive future for the next generation of Aboriginal and Torres Strait Islander people. Lani Tuitavake, the AHC's General Manager, believes future generations will have a chance to live and grow up at Pemulwuy, in a vibrant, safe environment that is sustainable over the long term.

"It's about giving our future generation a hand up, not a hand out," she said. "We want to give Aboriginal and Torres Strait Islander people the opportunity to live at Pemulwuy with modern housing that is culturally appropriate in a safe, community minded environment".

Every resident that lives at Pemulwuy will be an ambassador for Aboriginal and Torres Strait Islander people.

With the Pemulwuy Project, the AHC will provide opportunities for Aboriginal and Torres Strait Islander people through employment, training, education, and scholarships. The community will be able to access significantly increased social and economic benefits as a result of the project. There will be new jobs and training opportunities across construction, childcare, administration and retail.

The AHC plan to implement long-term contracts and apprenticeships during and after the construction of the Pemulwuy Project. Lani Tuitavake stated that often long-term employment opportunities are difficult to secure, with many contracts lasting between three to six months. The student accommodation in Precinct 3 of The Pemulwuy Project will be another avenue for these students to enjoy a local community, safe haven and support system. Students will also experience the cultural aspects of an urban, Aboriginal and Torres Strait Islander community.

AUSTRALIA'S leading street artists have welcomed a City of Sydney proposal to ease ease restrictions on street art, effectively allowing any privately owned surface to become a canvas.

become a canvas. Following a review into public art, the council has recommended a change to its local environmental plan, al-lowing murals, grafiti and other forms of street art to be undertaken without council approval. The plan cuts red tape and allows property owners to

allows property owners to decide for themselves what goes on their walls.

Apart from a few caveats. including provisions the art is not advertising, does not discriminate, is not sexually degrading, and does not in-fringe intellectual property rights, street artists have

rights, street artists have free reign. Sydney-based and inter-nationally recognised street artists Scott Marsh and An-thony Lister applauded the move as a vital step towards handing back public space to the neonle

the people. "I think it's definitely a positive thing in terms of supporting artists," Marsh

The street artist, whose recognisable work includes the Fat Tony/Mike Baird mural in Chippendale, said property owners would property owners would often ask him to do a mural but give up when they re-

alised the red tape involved. "Homeowners should be able to do whatever they want," he said. Anthony Lister, best known for his ballerina se-ries and prominent "Lister" ries and prominent Lister signature, welcomed the move as a step towards the decriminalisation of graffiti. "I'm a believer in public spaces being for public peo-ple," he said.

# 'The Block' to house 500 university students in 16-storey tower as part of new plans

It is synonymous with the modern history of Sydney's Aboriginal people, but 500 students could soon call The Block home as part of a drastically revised blueprint for the inner-city site.

The Aboriginal Housing Company has lodged an application with the Department of Planning to increase the size of a development opposite Redfern station.

Plans approved in 2012 paved the way for a six-storey, mixed-use building to house about 150 students in 42 units.

But the development would increase to 16 storeys and include more than 500 bedrooms under the new proposal.

The revised plans are part of the Pemulwuy Project, which includes three adjacent precincts between Louis Street and the railway line, known as "The Block".

The student accommodation is part of precinct three. The other two precincts are for affordable housing for Aboriginal people, as well as commercial and retail space.

AHC chairperson Alisi Tutuila said increasing the size of the student housing development would mean the entire Pemulwuy Project remained financially independent.

"We are extremely excited about this new model to deliver the Pemulwuy Project in a way that realises our core objectives for our community," she said.

"We will now be able to deliver the Pemulwuy Project as a whole in one stage, and there will be no changes to the affordable housing solution for Aboriginal and Torres Strait Islander families, which is our core objective.

# Community meeting at The Block shut down as anger spills over

Land on The Block will be handed to a student housing provider under a 99-year lease, it was revealed at a fiery public meeting on Thursday.

About 200 people attended the Redfern Community Centre to hear the AHC explain its plans to build a 16-storey student accommodation building on The Block as part of the site's redevelopment, called the Pemulwuy Project.

Paul Keating's Redfern Park speech Then Prime Minister Paul Keating publically acknowledges the injustices experienced by Aboriginal Australians at Redfern Park in 1992.

But attempts to win community support for the project were defeated and the meeting called off, as former residents of the historic site accused the Aboriginal Housing Corporation of selling out the community.

Many members of the Aboriginal community were in the audience, including former residents of The Block, and founders of the Tent Embassy protest which occupied the site for more than a year until August 2015.

Soon after the meeting started, audience members – irate at the AHC executives and the new plans being proposed – interrupted proceedings, accusing the AHC of mismanagement and demanding the Aboriginal people who founded The Block be heard.

After repeated attempts to regain control over the proceedings, which was to include a slide show presentation, AHC chairperson Alisi Tutuila said: "We are actually going to have to call off this meeting."

The meeting was expected to be tense.

Two weeks earlier, the AHC unveiled its revised plans for the \$70 million Pemulwuy Project. The proposed six-storey student accommodation facility, which was to be built alongside a new Aboriginal housing precinct on The Block, had been raised to 16 storeys.

The unit block would house 522 students, instead of the 154 students catered for in the original plans.

As Ms Tutuila outlined the details of the revised plans on Thursday, which centred on granting student accommodation provider Atira a 99-year-lease over the propose site in exchange for an upfront payment of rent, attendees at the meeting grew restless.

The leasing arrangement, Ms Tutuila said, would enable the AHC to deliver the project in one stage, while remaining financially independent without having to "hand over a legacy of debt to the next generation".

Under this model, which was developed by accounting firm KPMG, the student housing component will fund the building of 62 affordable homes for indigenous people, which the AHC maintains is the primary goal of the Pemulwuy Project.

"At this point there is no other money available to build the affordable housing," Ms Tutuila told the audience.

But as AHC general manager Lani Tuitavake took to the microphone, attempting to frame the significance of the Pemulwuy Project as the realisation of The Block's Aboriginal history, members of the audience erupted.

"You do not have the right," one person yelled. "You don't speak for black people. You sold us out."

By the time an architect from Turner & Associates had assumed the microphone to explain the design of the student precinct, the organisers had lost control of the meeting.

A founding member of The Block's Aboriginal community, Lyall Munro, who was among the meeting's interjectors, then assumed control of the microphone.

"This has become emotive. However, it's been an emotive situation for many, many years."

Addressing the AHC executive, he said: "Your plan is not a reflection of our plan."

Mr Munro's speech touched on the deep divisions between the between the AHC and sections of the Aboriginal community, which have emerged in the decades since the Whitlam government granted the AHC \$500,000 to purchase land on The Block in 1972.

AHC's critics believe the company is now a private operator which has long since jettisoned its community organisation roots.

"I'm not shocked it ended this way," Nathan Moran, CEO of the Metropolitan Aboriginal Land Council said. "On so many levels this project fails the community."

Ms Tutuila said AHC organisers were disappointed they were forced to cancel the meeting.

"I was approached by a number of community members after the event who also expressed their disappointment to not hear the presentation in full."

A community meeting to provide information about a radically enlarged student housing development at the Block in Redfern came to an abrupt end after protesters disrupted the event and the meeting was closed.

The <u>Aboriginal Housing Company which owns the Block has applied to the NSW Department of</u> <u>Planning</u> to increase the size of the development from 6 to 16 stories to provide housing for 522 students, up from 154, without any increase in new social or Aboriginal Housing, which remains at 62 homes. The student housing would be sold to commercial operator Atira on a 99-year lease.

The meeting was interrupted 25 minutes after starting, when members of the audience began to shout and overwhelm speakers, expressing anger at the plans for increased student accommodation.

Protesters yelled, "no one cares" and demanded to go straight to the question and answer session.

Aboriginal Housing Company General manager, Lani Tuitavake, told the audience the reason for the lease was to avoid incurring in debt to fund the development of the Block and the creation of Aboriginal housing, so that no part of the land would be sold.

"This is for the next generation. For years we have endured substandard housing, crime and mismanagement," she said.

"There are people out there that deserve an opportunity to be able to raise their children and to be able to live in good standard housing for Aboriginal people."

Her comments were met with cheers and claps from some sections of the audience, while others shouted: "You sold us out!" and "we don't want it".

Journalist Deborah Cameron, who was at the event as an independent facilitator, was repeatedly shouted over and called a "white woman". She was unable to keep control of the proceedings, as she was scolded by people screaming, "you don't understand, you'll never understand".

The increasingly tense meeting was briefly stopped when, about 30 minutes in, an audience member experienced a seizure and was taken out. The woman returned shortly after and was able to resume her seat.

Lyall Munro, one of the original founders of the Block, stood up and attempted to address the audience in the middle of the meeting, but the microphone was cut off. Undeterred, Mr Munro continued to address the audience. He explained the issue had become very "emotive for many many years" and said the vision of housing for Aboriginal people had been lost.

"It's not just Martin Luther King who had a dream, there's Aboriginal people, black Australians who had a dream, and that dream's been thwarted and it's sad."

"Your plan is not a reflection on our plan," he said, before labelling the AHC's proposal as an "Asian student Taj Mahal"

One woman attempted to bring in a "battle for the Block banner", but was pushed out of the room by another audience member.

After 30 minutes, the AHC co chair Alisi Tutuila cancelled the meeting amid shouts and more heckling from the audience.

# Government funding on hold

The AHC has blamed a lack of government funding as a key reason for the dramatic increase in the scope of the development.

<u>NITV News was told</u> by the office of the Minister for Indigenous Affairs, Nigel Scullion, that the AHC has not attempted to access a \$5 million grant offered by the Government last year to cover the cost of 62 affordable homes.

"The Minister has not received any requests from the AHC to progress this grant, but remains committed to working with all stakeholders on this project," the spokesman said.

The \$5 million was put on the table to end a standoff between Indigenous activists and the AHC over the future of the development, with activists claiming the AHC had sold out the local community to increase profits, something the AHC has strongly denied.

AHC Chairperson Alisi Tutuila said the organisation had been in regular contact with the government in relation to the \$5 million grant.

"At our last meeting with the Minister's advisor late last year, the Minister's office presented the terms of the grant to the AHC. However, the AHC proposed the grant to be released once we have obtained a certificate of occupation on completion of the project, which minimises the risk on the Government," she said in a statement to NITV News.

"At this stage, the terms of the proposed government grant have not yet been agreed to."

# Redfern's the Block redevelopment public meeting prompts angry protests

# A public meeting on the latest redevelopment plan for the Block in Redfern had to be shut down after 30 minutes amid angry protests.

Around 300 people packed into the Redfern Community Centre for the first public consultation.

Several members of the Aboriginal community voiced their unhappiness with the proposal for a 16-storey building to accommodate more than 500 students.

"Our generation has been displaced," one young woman shouted from the back of the hall.

The Chair of the Aboriginal Housing Company Alisi Tutuila revealed that the plan was to lease part of the site to the private student accommodation provider Atira for 99 years.

She told the meeting the rent would be paid upfront, allowing 62 affordable homes for Aboriginal people to be built with "no financial burden, no debt, no handing over of debt or legacy to the next generation".

Ms Tutuila said it would enable the affordable housing to be built at the same time as the rest of the development.

### "Here is a solution that we are sharing with you. We're no longer striving for this. We're at a point where we can confidently say we're ready to deliver the affordable housing."

Among those in the audience was Lyall Munro, the sole surviving member of the group of eight who travelled to Canberra in the 1970s, returning with a grant of \$530,000 that allowed the Aboriginal Housing Company to buy its first houses in Redfern.

"Where here has it been mentioned about the Aboriginal homes, about the dreams of the founders of this place?" he asked.

"It's not just Martin Luther King who had a dream, there's Aboriginal people, black Australians who had a dream and that dream's been thwarted and it's sad."

# 'A hindered opportunity'

The meeting was due to run for 90 minutes but was brought to an abrupt end as speakers were shouted down and heckled from the floor.

At one point, a lone female protester carrying a banner reading "Battle for the Block round 2" tried to enter the meeting.

She was bundled out by a woman who had been sitting in the front row.

Supporters later claimed the protester had been assaulted.

Speaking afterwards, Ms Tutuila said she was surprised at the way the meeting ended.

"It was disappointing that it had to be shut down due to a minority group of people who hindered an opportunity for other community members to hear more about the program," she said.

The Chief Executive of the Metropolitan Local Aboriginal Land Council, Nathan Moran, was among those watching proceedings.

"Given that this is the only time the community's had a chance to talk about this project or hear about it with some factual information, it was natural that we would have that response and reaction," he said afterwards.

# "Originally the place was Aboriginal affordable housing for a community and now we're talking about commercial developments for the benefit of non-Aboriginal students."

Altira is one of the country's largest providers of student accommodation.

Its website says the company was formed as a partnership between investment group Goldman Sachs and Blue Sky Alternative Investments with a goal to acquire and operate accommodation for 10,000 students around Australia.

The Federal Government has rejected claims by the Aboriginal Housing Company that funding for the Pemulwuy project in Sydney has stalled, saying the Aboriginal Housing Company has not attempted to access \$5 million in funding allocated to the project.

Earlier this week the AHC blamed a significant increase in the commercial aspects for the redevelopment of The Block in Redfern on a lack of alternative funding, saying it had to ensure the project was commercially viable for it to proceed.

Activist and Wiradjuri Elder Jenny Munro who started the tent embassy at The Block in 2015 and led the fight to guarantee Aboriginal housing would remain as part of the redevelopment of The Block has criticised the push for more student housing.

"I think it just demonstrates more greed," she told NITV News.

n the inner <u>Sydney</u> suburb of Redfern, residents, developers and Indigenous activists are pondering a drastic change to the skyline.

The suburb's historic Block – the first urban Indigenous land rights claim in Australia – has been earmarked for a dramatic new extension to an already contentious development, which some residents say will hasten the gentrification of a suburb with a strong Indigenous history.

Under a proposal lodged late last year by the Aboriginal Housing Company (AHC), the site will accommodate a student accommodation complex of 16 storeys and more than 500 dwellings, in what the City of Sydney called a "significant departure" from previously approved plans.

When the <u>Pemulwuy Project</u> was first approved in 2012, it was capped at six storeys, yet it drew an intense and prolonged protest. In 2014, activists <u>occupied the site with a tent</u> <u>embassy</u>, demanding more social and affordable housing for the suburb's long-term residents.

The standoff was ended with a <u>\$5m pledge from the Indigenous affairs minister</u>, Nigel Scullion, to fund the construction of 62 affordable homes.

But the AHC chairwoman, Alisa Tutuila, said government funding has stalled, and with no proposed increase in the number of low-rent homes, opponents of the \$70m development say the new plans will accelerate change in Redfern.

"They're acting as a private developer not a community organisation," said tent embassy organiser and Wiradjuri elder Jenny Munro. "If they can build 500 housing places for students, they could build a lot more houses for our people. This is being driven by profit, and that's the problem. The community misses out badly."

The <u>University of Sydney students' reprentative council's</u> student housing officer, Jenna Schroder, said it was "disappointing the project has not seen an increase in the number of affordable dwellings for Indigenous residents".

"The Pemulwuy Project offers nothing special or affordable for students with its rent prices, preying on the international student market like many residential buildings in the area," she said.

But Tutuila said the proposed increase in student housing was the only feasible way to deliver low-rent homes.

"There has been no specific government funding to cover the entire precinct of affordable housing. The \$5m grant is actually still in negotiations with the minister's office, and in saying that, doesn't cover the whole cost," she said.

"That's why we had to re-engineer this model, so it will allow us to yield off the extra height to build the affordable housing and the commercial precinct at once. The revenue from this model will allow us to build more affordable housing and future developments in the Sydney area."

A <u>letter</u> from the AHC to the New South Wales Department of Planning and Environment put the blame on "insufficient funds [from] the various levels of government and philanthropists", saying the AHC was "required" to fund the project with other means.

The AHC has owned the land around the Block since 1973 and Tutuila said she is "very confident we have overwhelming community support – both from Aboriginal and non-Aboriginal communities".

But Munro said she had been "excluded" from the process. She confirmed she would be making a submission to the council opposing the development and urged other members of the Aboriginal community to do the same.

The NSW planning department said the AHC had been issued <u>environment assessment</u> requirements for the project, which would require it to justify the proposed scale.

If the project receives more than 25 objections after it is put on public display, or if the council objects, the department will refer it to the independent Planning Assessment Commission.

The suburb also faces huge changes through the <u>Central-to-Eveleigh</u> revitalisation program, a high-density development project that includes a new metro railway station in nearby Waterloo and homes for an estimated 29,000 to 56,000 new residents.

The Waterloo public housing estate will alone accommodate <u>5,000 new private homes</u> and <u>14,000 new residents</u>, which the Sydney lord mayor, Clover Moore, labelled the densest residential development in Sydney.

In December, UrbanGrowth NSW, the government body overseeing Central-to-Eveleigh, made a submission in support of the Pemulwuy expansion, saying it supported "integrating new high-density mixed-use buildings with existing neighbourhoods and places".

Geoffrey Turnbull, from the Redfern-Waterloo community organisation RedWatch, was optimistic about the impact the Pemulwuy development would have on local residents.

"We won't know until we see the final diagrams and where those shadow diagrams go, but the afternoon sun will have as good as no impact on other developments," he said.



"In an ideal world it would be nice to have delivered on the project as it was put together, however they haven't been able to get funding and this seems at this point the only way. It's not the ideal outcome but it's far better than just nothing happening." Room to breathe: remote Indigenous communities and the battle to improve housing and jobs



Tutuila told the Guardian that further information on the project's timeline would be available at <u>a public</u> <u>meeting on Thursday</u>, but Munro has vowed to fight the development.

"We have a grave situation in relation to housing in our community. Our population in Redfern has gone from 40,000 when I came here as a young woman in the 70s to less than 300 now. It's all deliberately designed to push the black community out, that's what gentrification is about," she said.

"Our community will be moved out because of the pressure applied by both the public housing provider and the one Aboriginal housing provider the community historically relied on.

"If they think 62 houses will cater to the Aboriginal community in the inner city, they are living on Mars."

## Aboriginal Housing Company isn't 'bringing people together'

The Redfern Indigenous community has denied support for the Pemulwuy Project at The Block, despite such claims from the Aboriginal Housing Company (AHC).

The AHC recently lodged an application to the Department of Planning to increase student accommodation. To support the increase from 154 to 500 students, the building will need to be ten stories higher than the original plan.

Nathan Moran, the CEO of the Metropolitan Local Aboriginal Land Council (MLALC), said it's a big lie for the AHC to promote they have support from the Aboriginal community of Redfern.

"We are the Aboriginal community of Redfern, the Metropolitan Local Aboriginal Land Council. Whether the Aboriginal Housing Company likes that or not, we are the authority legislated to speak and we have never supported this development," he said.

Mr Moran said the AHC didn't consult the MLALC in regards to the modifications.

"I'm quite shocked that we have not even had the courtesy of a conversation from the housing company," he said.

"To have no negotiation, let alone discussion, as an Aboriginal community on options other than going for commercial use of the land is quite shocking. It's very devastating to be honest."

AHC Chairperson, Alisi Tutuila, said they included the local community in the development and planning of the Pemulwuy Project.

<sup>1</sup> "We've worked very hard in engaging with certain stakeholders in the community," she said.

Ms Tutuila said the modifications would benefit the local Indigenous community at Redfern.

"Apart from being able to provide 62 Aboriginal and Torres Strait Islander families with affordable housing dwellings, there will also be Indigenous scholarships for students, Indigenous employment opportunities as well as education and other pathway programs," she said.

The AHC said the decision to increase student accommodation is to ensure they are able to fund the construction of affordable housing on the site.

"There has been no government funding to cover the entire precinct, which the affordable housing is on.

"We've worked very hard to try and secure other funding from other avenues, including government, and there hasn't been any funding available – hence why we've had to increase to be able to yield off the height to be able to build the affordable housing," said Ms Tutuila.

MP Nigel Scullion, the Minister for Indigenous Affairs, committed a \$5 million grant to the Aboriginal Housing Company for the Pemulwuy Project in 2015 as a part of a peace deal made with the Redfern Tent Embassy.

The grant was contingent on affordable housing and commercial development being commenced at the same time.

A spokesperson for the Department of the Prime Minister and Cabinet said the Minster has not received any requests from the AHC to progress this grant.

Mr Moran disputes the claim the AHC exhausted other avenues to fund the Pemulwuy Project.

He said the MLALC offered AHC the opportunity to explore a financial partnership to develop The Block but they didn't respond to the request.

"I think it's very important to put out there. We're not just talking, we actually went to them and offered to mortgage a whole series of our assets," he said.

Mr Moran said the AHC are functioning as a commercial operation, which is in conflict to their original foundation.

"Their original foundation was to be an Aboriginal community housing provider for Aboriginal people and families to accommodation on The Block," he said.

The AHC named the project at Redfern after the Indigenous warrior, Pemulwuy, who lead the resistance against colonists in Sydney.

Mr Moran said the AHC never sought approval from the MLALC or the La Perouse Land Council where Pemulwuy belonged.

"They have shown total disrespect for the culture, the community and even that individual," he said.

The AHC will hold a community information meeting to address the modifications to the Pemulwuy Project on Thursday 9 March at Redfern Community Centre.

Ms Tutuila said the event provides a formal platform for the local Indigenous community to respond.

Mr Moran said this meeting is not a unique community consultation for the local Indigenous community but is part of the development application process.

A plan to add 10 storeys to a student accommodation building – forming part of a controversial redevelopment plan of the area known as The Block – has left Aboriginal residents furious, claiming it will "white-wash" the community.



Once a thriving Aboriginal community, The Block is now one of the most coveted parcels of land in inner city Sydney.

In the 1970s then Prime Minister Gough Whitlam granted the Aboriginal Housing Company (AHC) funds to purchase houses and land for the Aboriginal community. It was an ambitious and bold plan to create affordable low cost housing for disadvantaged Aboriginal people.

But by 2011 the last Koori community members living at The Block had been evicted and their houses demolished to make way for the Pemulwuy Project, a multimillion dollar redevelopment.

The project has been mired in controversy, and has drawn criticism from Aboriginal people over a lack of transparency.

In 2015, the Redfern Aboriginal Tent Embassy (RATE), a group of community members headed by elder Jenny Munro, camped on the empty land and refused to leave until the AHC guaranteed that affordable Aboriginal housing would be built before commercial enterprises.

After a Supreme Court battle and intervention from the federal government, the AHC agreed to build Indigenous houses first, followed by retail spaces and a six storey student accommodation complex.

On Monday the AHC announced a dramatic change to the \$70 million Pemulwuy Project, saying it wanted to increase the student accommodation from six storeys to 16, thus increasing the number of students living there from 152 to more than 500.

The AHC says it's the only way it can pay for the 62 affordable homes for Indigenous people.

"The decision to increase the student accommodation component was made in order to make the Pemulwuy Project more financially viable," Alisi Tutuila, chairperson for the AHC, told BuzzFeed News.

"By increasing the student accommodation component, we are able to... build the entire Pemulwuy Project at once, and it also means we remain debt free." You're White-Washing Our Home: Aboriginal Community Opposed To Controversial Block Development - BuzzFeed News

Ken Canning, one of the founders of RATE, told BuzzFeed News that increasing student dwellings from six to 16 storeys was a "stupid" idea that would "completely overwhelm the Aboriginal community" and turn it into a "homogenous student community".

"We [RATE] fought very hard for Aboriginal accommodation, not for this," Canning said. "Once again we see Aboriginal people being pushed to the fringes; once again pushed out of Redfern. It's a complete white-wash, all for the dollar," Canning said.

Canning warned of clashes between the Indigenous community and students if the development went ahead.

"You are putting some of the most impoverished people next to international students who largely come from a wealthy background," Canning said.

"It's a volatile mix and it's inevitable [that] resentment will grow among the Koori community there, who feel like they are being dispossessed of their own land. Violence will break out."

# LETTER FROM THE ABORIGINAL HOUSING COMPANY TO THE LOCAL COMMUNITY



The Aboriginal Housing Company (AHC) continues to be committed to informing the community of the progress of the Pemulwuy Project, Redfern.

Earlier this year we presented a revision to the Col James Student Accommodation for Precinct 3, as part of a modification to the approved Concept Plan; in more recent months the project has been through a process of Design Excellence, facilitated by the "Office of the Government Architect".

In light of the Design Excellence, there will be a modification to the latest concept plan for Precinct 3. The previously presented 522 rooms across 16 floors, have been amended as an outcome of Design Excellence, and will now be 23 floors of student accommodation with no change to the proposed 522 student rooms. The current proposal for Precinct 3 has been developed in consultation with the independent Design Review Panel, as established by the Department of Planning and Environment, which identified matters for consideration.

Over the past four months and through six separate sessions, the panel raised the following strategies for an enhanced design outcome and the current proposal is the result of the implementation of these strategies.



#### ARTICULATED BUILT FORM

The bulk of the building has been amended with additional height, located to the centre of the site, along the eastern aspect of the building and alongside the rail corridor. This approach has allowed for the building to be pulled back from Lawson Street to create a public space, and the resulting undulating built form generates a low scale built form to Eveleigh and Lawson Street.

#### CREATION OF PUBLIC MEETING PLACE

The building has been pulled back from Lawson and Eveleigh Streets to the south to reinforce the corner and to create an open public space. This space is to be landscaped with trees, seating and public art, including an art wall.

### **EVELEIGH STREET STREETSCAPE**

The variation of height has been a considered approach in order to relate appropriately to the existing and immediate context and streetscape. The height of the west wing, along Eveleigh Street, has been reduced to three storeys to reflect the overall height of the adjoining terrace houses along the street and the proposed low scale buildings of Precinct 1 of the precinct.

### CREATION OF CENTRAL COURTYARD

The building has been split into east and west wing to the north to create a central courtyard within the proposed student accommodation. This will allow for landscaping within the centre of the building.

#### RETAINING THE NUMBER OF ROOMS

The proposed development has consistently retained the 522 rooms for student accommodation.

#### As ever, the AHC is committed to delivering on its core objectives including:

- To deliver quality affordable housing to the Aboriginal and Torres Strait Islander community
- To retain full ownership and control of the site
- To create history for the Aboriginal and Torres Strait Islander people through a new era of selfdetermination
- By delivering this project to the community with no financial burden to our future generation. This means that they too can maintain long-term financial independence.

As part of the delivery of the Pemulwuy Project the AHC will be implementing opportunities for employment, education and apprenticeships. We are also looking forward to leading the cultural heritage education for the Pemulwuy Project as part of student life.
