Thank you for referring the Proponent's Response to Submissions listed above to Sydney Water.

We have reviewed the relevant documents and provide following comments for your information.

- The proponent (Frasers) started with the residential dwelling yield of 1058 in their original proposal in 2012. The number was increased to 1220 dwellings in 2014, when Sydney Water completed its detailed service planning, then again increased to 1420 dwellings in 2015. In the subject modification of the Concept Plan, the proponent further increased the ultimate lot number to 1566 with some medium density residential development as well and associated commercial development.
- Sydney Water has advised the proponent that our planning and infrastructure can accommodate up to a maximum of 1422 dwellings, although we considered 1220 in our planning.
- Sydney Water met with Frasers Property in regard to the proposed increased development yield at the Shell Cove Boat Harbour site on Monday, 26 March 2018.
- To assess serviceability of the proposed 1566 dwellings and associated commercial areas, Frasers needs to carry out further servicing investigations in consultation with Sydney Water. This investigative study, to commence soon, will determine whether there is adequate/sufficient capacity in the local wastewater system to accommodate the additional growth.
