5. Describe the modification you propose to make

The Sydney Harbour Foreshore Authority is seeking to modify the Concept Plan to allow for a more naturalised Headland Park and enlarged Northern Cove.

This will require the following changes to the approved Concept Plan:

- the new street referred to as "Globe Street" to turn east towards Hickson Road south of the northern cove, rather than continue northwards around the headland;
- removal of Block 8 and part of Block 7 to accommodate an enlarged northern cove; and
- removal of the Sydney Ports Harbour Control Tower, MWS&DB Sewage Pumping Station and sandstone seawall, all of which are listed as s170 heritage items on the respective agency registers.
