It has a quiet ambience about it that we greatly value and treasure. The inclusion of a heliport in the Trinity Point development would amount to an act of ecological vandalism.

The noise created by the approach, departure and landing and taking off of helicopters over the lake, houses and amenities of the area would create a totally unacceptable cacophony of sound which would seriously detract from the quality of life we have enjoyed in the area for so many years which had a major bearing on many of the residents choosing to live in the area in the first place. Interestingly, the developer does not live in the area or even in the general local area so he will not have to suffer the noise and inconvenience that his grasp for dollars creates. He just leaves all of that for us.
