DPI Fisheries provides the following comment on the Addendum RTS for MP 09_0131 MOD 1 at Tallawarra Lands, Yallah:

- 1. To maintain the ecological health of Lake Illawarra it is important that final stormwater treatment measures are designed in accordance with the 'improve' targets set under the risk-based framework for waterway health outcomes. As stated in previous correspondence from DPI Fisheries the MUSIC modelling accompanying this proposal compares the performance of the developed site with water quality protections against the performance of the developed site without water quality protection. This simply indicates that the discharging from the site will be somewhat better with the proposed stormwater treatments in place compared to what it would be without any stormwater treatment. A necessary analysis is to compare the existing site (i.e. grazing and forested land) against the development with water quality protections in place to show whether the development could achieve agreed water quality targets.
- 2. The MUSIC modelling predicts that the proposal in its current form will discharge 6970 kg of Suspended Soils, 40.6 kg of Phosphorus, 483 kg of Nitrogen and 32.3 kg per year of Gross Pollutants to the waters of Lake Illawarra every year of the life of the Development. DPI Fisheries questions how such discharge compares to the current discharge from the site and whether this meets the 'improve' requirement under the risk-based approach to stormwater targets for waterway health.
