Further to our discussions this morning regarding the email below and our discussions yesterday regarding the reason the additional testing wasn't completed in the central precinct please consider the following:

Central Precinct

The only increase in urban footprint is within the green area, thus it's all low archaeological potential.



The report recommends the following:

Recommendation 4: No further archaeological assessment is required in areas of low archaeological potential

No further archaeological work is required in areas identified as having low archaeological potential except in the event that unexpected Aboriginal sites, objects or human remains are unearthed during development (refer to Recommendations 8 and 9 below).

Northern Precinct

The increase in urban footprint is within both the orange (medium) and green (low) areas, in particular the area under the power line.



The report recommends the following:

Recommendation 1: Further archaeological assessment is required in areas of moderate archaeological potential

Areas identified as having moderate archaeological potential should be avoided wherever possible (Figure 10). If impacts to these areas cannot be avoided subsurface investigations (test excavations) will be required prior to the commencement of works as a condition of the DA or concept approval. Test excavations should be conducted in accordance with the Code of Practice for archaeological investigation for Aboriginal objects in NSW (DECCW 2010a) and Aboriginal cultural heritage consultation requirements for proponents in New South Wales (DECCW 2010c).

Based on the information above we don't believe any further justification is required from Biosis as to why the field work wasn't completed in the central precinct. Can you please confirm this is the case so we can have the reports issued for review ASAP?
