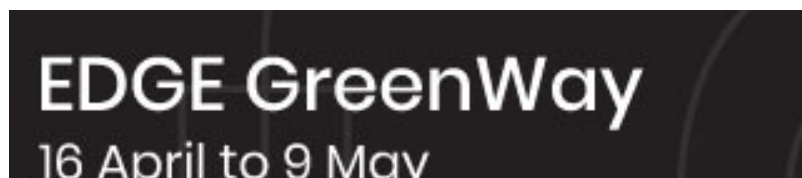
Subject to the amendment to condition B7 (outlined above), Council has no objection to the proposed amendments.
