Biodiversity

1. Further information has been provided to address previous recommendations on biodiversity

Further information has been provided on recommendation 1 raised in BCD's letter dated 17 January 2022 (DOC22/14445-16). In this correspondence BCD requested that the proponent submit either: (i) a Biodiversity Assessment Development Report (BDAR) done in accordance with the Biodiversity Assessment Methodology 2020; or (ii) a BDAR waiver under section 7.9 of the *Biodiversity Conservation Act 2016*.

BCD notes that the option of producing a BDAR has been followed, in accordance with Appendix C of the BAM 2020, 'Streamlined assessment module – Small area'. This is due to the fact the amount of clearing is < 1ha (in this case less 0.14 ha) within a lot size of less than 40 ha (in this case 1.27 ha). BCD concurs that this fits the 'streamlined approach' within BAM 2020, and supports its use.

BCD has assessed the BDAR and concurs it has been prepared in accordance with BAM 2020, and the biodiversity credit requirement has utilised the BAM-C (credit calculator). The proposal is not likely to result in a significant impact, and the development site does not meet the habitat constraints of any of the candidate species credit species that are candidate Serious and Irreversible Impact (SAII) species. As such BCD concurs BAM 2020 has been applied correctly and has no further comment.
