24 Jan 09	As a long time resident and a founding member of the Double Bay Residents Association, I was extremely disappointed with the design of your proposed development. I am NOT against development in the Bay. In fact, I welcome it. I am a journalist, who at the time, advocated the building of the Ritz Carlton Hotel. Unless the Bay (read Council) adopts a modernisation and reasonable expansion plan for the area, its cache as a prestigious shopping centre will die. I have watched so many businesses close over the years. So many people have lost money simply because the rents are too high. You can't blame owners trying to get a fair return on their investment and this is where the Council could get involved by giving the Bay concessional rates due to its special heritage and tourism value. But that's another story. I would like to see the Double Bay School go and the flat open land turned into free parking. I would also like the height restrictions eased in many streets - they are only stalling the inevitable by retaining the status quo. Now, my criticism of your design rests mainly on the single leaflet that arrived in my mailbox. It shows those very treacherous and dangerous European-style cobblestones in your piazza - a recipe for litigation. I can name at least six people who have brought action already in the Bay because of uneven ground - and this is on relatively flat surfaces! I just couldn't believe that any architect/developer would construct in the year 2009, a duplicate of those 1960 dog boxes fronting onto your unimaginative fountain. This flimsy, pre-fab affair is a prime example of why developers get a bad press. It's not what is the best we can do, but what can we get away with. Back to the drawing board! There are many other suggestions I could put forward, but I'll leave those until I have seen the scale model.
