Hi Jackie,

The most recent advice that we sent to Dept Planning in March 2009 indicates a need for a 1.35-hectare extension to the existing Minmi PS site (to bring it up to three hectares) and for a four-hectare site (for a combined primary school and special needs school) in the Link Road South Precinct. This is consistent with advice sent to Keith Deddan, GM, Property Development in Coal & Allied) earlier this year. Copies of both are attached.

The DET owns a three-hectare vacant primary school site in Cameron Park (west of C&A's Link Road South lands) that is being retained for potential future need to cater for further new residential development there. I anticipate that the identification of a further primary school site in Edgeworth (in the C&A lands) could also be required if/when the proposed extent of residential development eventuates there.

We will continue to monitor the situation.
