Re: Rural Residential Subdivision of Lots 1-80, 83, 84, 86-88 DP791199 and Lots 90-95 DP805549, Le Clos Verdun Estate, Sancrox

I note that in October 2007 Midcoast Environmental Services prepared a bushfire hazard assessment with respect to the proposed rural residential subdivision of land known as Lots 1-80,83,84, 86-88 DP791199 and Lots 90-95 DP805549, Le Clos Verdun Estate, Sancrox. It is noted that the lot layout of the proposed development has now been modified from that which was considered by Midcoast Environmental Services in its October 2007 report, refer to **Attachment 1**.

As requested the proposed changes to the lot layout have been reviewed by Midcoast Environmental Services in terms of the application of the relevant requirements of NSW Rural Fire Services, *Planning for Bushfire Protection*, 2006 to the proposed new lot layout. In this regard the proposed lot layout continues to provide for compliance with NSW Rural Fire Services, *Planning for Bushfire Protection*, 2006 with the findings and recommendations of Midcoast Environmental Services October 2007 report still applicable to the development inclusive of the proposed lot layout changes.


It is further noted that there are changes proposed in relation to the location of the system of fire trails which are proposed to be provided as part of the development of the rural residential subdivision, refer to **Attachment 2**. As requested the proposed new fire trail locations have also be reviewed by Midcoast Environmental Services and have been found to be consistent with the recommendations contained within its October 2007 bushfire hazard assessment report and NSW Rural Fire Services, **Planning for Bushfire Protection**, 2006.
