THE revised plan for the \$220 million Kirrawee brick pit development which almost doubles the size of

almost doubles the size of the original proposal has gone on exhibition.

Sutherland Shire meyor Phil Blight is urging all residents to comment on it before the February 11 deadline for submissions.

Developer Hemoth Investments Development has submitted the plan for eight high-rise towers ranging from four to 17 levels, with 493 units. 13.450 source metres units, 13,450 square metres of retail space, including two

supermarkets, 9000 square metres of parkland, and parking for 1349 cars.

The final decision is out of the hands of the council and will be made by the Planning Department under its controversial Section 3a legislation. Shire business owners viewed a new model of the development last week. Bettina Hoffman from Kirawae Chamber of Commerce said the developer had completely disregarded zoning requirements for the site.

good reason to," she said. Sutherland Shire Chamber of Commerce president Tony Mills is concerned about the effects of the development on the shopping centres of Kirr-awee, Gymea and Sutherland.
