Dear Mr Woodland,

Thank you for your letter of 13 December 2010 about the proposed residential development at Avon, Beechworth and Arilla Roads, Pymble. Sydney Water has reviewed the proposal and provides the following comments for the Department's consideration.

Water

The site does not front an available drinking water main with sufficient capacity. To service the site with drinking water, the developer can either:

1. Design and construct a 200 mm extension from the existing 250 mm main at the intersection of the Pacific Highway and Livingstone Avenue (refer to the below plan). This will provide a point of connection to the front of the property.

of the property. 2. Design and construct a 200 mm extension from the existing 375 mm main at the intersection of Beechworth Road and Avon Road. This extension will run parallel to the North Shore Railway line, as seen on the plan below. This will provide a point of connection to the front



attached with the extension design. The extension will need to be sized and configured according to the Water Supply Code of Australia (Sydney Water Edition WSA 03-2002). Evidence of Code compliance should be

to Point B and Point C to Point D in the diagram below. The 225 mm wastewater mains need to be upsized to a 300 mm wastewater main from Point A

The 300 mm wastewater main from Point B to Point C does not need to be upsized



The proposed wastewater infrastructure for this development will be sized & configured according to the Sewerage Code of Australia (Sydney Water Edition WSA 02-2002).

Sydney Water Servicing

Sydney Water will further assess the impact of the development when the proponent applies for a Section 73 Certificate. This assessment will enable Sydney Water to specify any works required as a result of the development and to assess if amplification and/or changes to the system are applicable. The proponent must fund any adjustments needed to Sydney Water infrastructure as a result of any development.

The proponent should engage a Water Servicing Coordinator to get a Section 73 Certificate and manage the servicing aspects of the development. The Water Servicing Coordinator will ensure submitted infrastructure designs are sized & configured according to the Water Supply Code of Australia (Sydney Water Edition WSA 03-2002) and the Sewerage Code of Australia (Sydney Water Edition WSA 02-2002).

Sydney Water requests the Department to continue to instruct proponents to obtain a Section 73 Certificate from Sydney Water. Details are available from any Sydney Water Customer Centre on 13 20 92 or Sydney Water's website at www.sydneywater.com.au.
