## CONCEPT PLAN (MP08\_0207) & PROJECT APPLICATION (MP10\_0219) – EXHIBITION OF ENVIRONMENTAL ASSESSMENT FOR RESIDENTIAL DEVELOPMENT AT AVON, BEECHWORTH & ARILLA ROADS, PYMBLE

I refer to your letter dated 13 December 2010 regarding the residential development at Pymble. Transport NSW appreciates the opportunity to provide input to this application.

Transport NSW has reviewed the *Concept Plan* prepared by Sheridan Planning and the appended *Parking & Traffic Report* and *Access Report* prepared by Gennaoui Consulting and Accessibility Solutions respectively.

Transport NSW requests that a number of matters be resolved to support the objectives, targets and initiatives of the *NSW State Plan 2010*, the *Metropolitan Transport Plan: Connecting the City of Cities, Integrating Land Use and Transport policy package, Planning Guidelines for Walking and Cycling and the Healthy Urban Development Checklist:* 

- The Environmental Assessment does not address the Director General's Requirement to "provide an assessment of the implications of the development for non-car travel modes". This requirement needs to be addressed prior to any decision on the *Concept Plan* having particular regard to impacts for bus and rail networks, together with consideration of pedestrian and cycle access;
- TNSW is concerned that the proposed level of car parking is not a minimalist approach and is higher than the maximum requirement. A minimum requirement of 52 spaces is requested;

- In addition to basement level bicycle storage facilities, bicycle racks should also be provided for visitors at ground level, near entrances, in a visible and weather protected location and subject to casual surveillance, in accordance with the *Planning Guidelines for Walking and Cycling.* TNSW notes the *Parking & Traffic Report* identifies 22 bicycle storage spaces as a minimum requirement for Stage 1; and
- The preparation of a sustainable travel plan should be included as part of the draft Statement of Commitments. TNSW directs the applicant to the Roads and Traffic Authority website, <u>http://www.rta.nsw.gov.au</u>, for further information on the preparation of travel access guides.

Railcorp will separately provide a submission regarding potential impacts on the existing rail corridor.

Finally, the following key policy documents may be of assistance in finalising the proposal:

- *Metropolitan Transport Plan: Connecting the City of Cities*, NSW Transport and Infrastructure, 2010;
- NSW Bike Plan, NSW Government, 2010;
- Planning Guidelines for Walking and Cycling, NSW Department of Infrastructure, Planning and Natural Resources, Roads and Traffic Authority, 2004;
- Section 117 Direction 3.4 Integrating Land Use and Transport, NSW Department of Planning, 2005; and
- *Healthy Urban Development Checklist*, NSW Health, 2010.
