Submission / Comments\*: I am very concerned to hear about the proposed redevelopment of the former Graythwaite site. There is likely to be severe damage or destruction of Anzac and garden heritage, the native fauna and therefore upset the balance of a micro ecosystem. Also, it will increase the pressure on very limited parking spaces in our community, and make already hazardous traffic conditions in the narrow residential streets even more hazardous. I request that a public enquiry be held to ascertain reasonable use for the site and provide detailed examination of the impact of upsetting the ecosystem of this area.
