I object to the proposed development because I have concerns about the increased traffic along the section of Reservoir Road, from the roundabout off the M4 Motorway to the intersection of Reservoir Road and Watch House Road

I attended a presentation by Matthew Fisk, Project Director, at which he stated that he or the company that he represented denied having an knowledge about the traffic surveys and the major re-alignment to Watch House and Reservoir Roads. Mr Fisk advised that a fee of approximately 5 million dollars had been paid to the RTA to undertake the assessment process of the adjoining roads and that his company had no input into the outcome of the road changes.

In the Part 3A Application there is an extensive section on the proposed re-alignment of Reservoir Road, Watch House Road, the construction of turning lanes and the installation of traffic signals. Surely the Project Director would have been aware of the proposed major road changes. This section of Reservoir Road, formerly known as 'The Western Road' and once travelled on by Governor Macquarie in the early 1800s, is the only section of this historical road left in its original location. This road should be of National Significance historically and should be preserved and included in a development that is more sympathetic to its historical value.

I am also concerned that there will be major earthworks to reduce the height levels of the hill near Watch House Road, to construct the entrance and carpark for 'Wet n Wild'. How can your Department allow this to happen to the area known as the Prospect Common, which has links back to Governor Arthur Phillip and First Fleeters in 1790.

Please seriously consider in not allowing this proposed Part 3A Development to proceed.

I am pleased to see that the use of tree and plants to provide shade was considered in this submission, and may I encourage you to extensively use these as much as possible.

Also, in terms of transport I think it would be fitting for there to be express buses to and from the park from both Blacktown and Parramatta Stations. The cost of these should be included in the entry ticket (much the same as parking is included.)

Further, an off road Bicycle and walking path between the park and:

- The M7 bike path,
- The Sunnyholt Rd Bike path (Blacktown Station)
- Parramatta Bike Path

All three of these bike paths link up with quite distant regions of the city.

This will also require change rooms and lockers, which have already been considered in the project.

These measures should ease the strain on nearby roads and parking, both of which are expensive to upgrade and maintain.

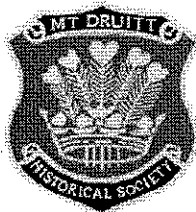

Thank you for the opportunity to comment on the proposal for the Wet n' Wild Sydney Theme Park at Prospect.

We have no objections to the proposal as outlined in the Part 3A Concept Plan Application by Prospect Aquatic Investments Pty Ltd on Lot 1, DP 1045771 Reservoir Road Prospect.

We would request, however, **that the final plans ensure** the restoration of the Police Station Cottage and the nearby trees in the precinct be retained, as proposed, and the building's use be either with some form of association with the park, or as a stand-alone venue, such as a tea room etc.

We would also request that the vista from the Police Cottage to St Bartholomew's Church be retained, as the report suggests.

We have some concerns about the capacity of the old highway to service the Wet n Wild site, and hope that the present historic alignment of the highway will be maintained, and if possible, restricted to two lanes. There is some concern in local historic circles that a four lane road, if constructed, would destroy the alignment of the old highway.

We feel that so much of the Cumberland Plain Woodlands has already been destroyed and respectfully request that as much as possible is retained in the area.
