To the Department of Planning and Infrastructure regarding Bomaderry Creek road proposal.

Bomaderry Creek Nature Reserve is a highly valued natural area to Bomaderry residents. Not only is it picturesque and absolutely beautiful, it is home to hundreds of species which will be threatened if the absurd Nerang Road bypass option becomes a reality. As a Land and Heritage Management graduate from the University of Wollongong, I can appreciate the amount of natural heritage in the reserve and it is immense. The Aboriginal heritage, which councillors are all aware of but as usual, tend to ignore, will also be jeopardised; these types of places are continually being destroyed and in no time there will be none left. The rainforest in itself is very valuable as it represents a unique environment within the sandstone gorge. The animal species the system supports are also precious, including Lyre birds, Yellow Bellied Gliders (which will be severely threatened if this road goes ahead) and the list goes on (which I'm sure your aware of because in putting through this road these issues must have been closely scrutinized!!). The physical road itself only excerpts a particular area, but the roads influence does not stop there. Rubbish from cars, fumes and general road grime will end up in the waterway below. Downstream of this, aquatic life will likely no longer exist; except of course algae which will further inhibit life. I regularly walk in the reserve and nearly always see Water Dragons which will be affected, and once one thing is upset in a fragile ecosystem the whole thing will have disruptions.

Another concern of mine is the inadequate priorities of council. The West Cambewarra Road option is by far the most viable as the reserve will not be disruption, however the public is quite aware that a number of councillors reside in this area whose properties may decline in value- the main reason why Nerang Rd has become an option. When will the time come when we have to say enough is enough? NOW. Leave our natural areas alone.

I have included a photograph of Bomaderry Creek to refresh your mind on the regions beauty, and to show what could be lost.









