The majority of local residents who will be most negatively impacted by the development have not received contact from AMP until a 3rd newsletter dated August 2010, nor were they door-knocked or contacted by phone.

Phone polling was conducted at 2pm on a weekday related to shopping preference rather than consultation on impact of proposed development of the Metro shopping centre, about which no information was provided.

A community group opposing the expansion have communicated with more than 1500 local residents and almost all were under the misconception that Marrickville Metro Shopping Centre is undergoing a "revitalisation".

Residents assumed revitalisation meant modernising and renovating the current centre. Nobody realised the actual size and scale of the proposed expansion.

Dear Minister Kelly,

As you are no doubt aware, AMP Capital Investors, owner of Marrickville Metro Shopping Centre, has submitted plans to your department for the redevelopment of The Marrickville Metro Shopping Centre.

AMP proposes a 115% increase in gross floor area and a 65% increase in parking for Marrickville Metro. The plan includes prohibited development – expansion of retailing on the industrial zoned land.

There are more than 2000 residences within 600m radius of the centre of Marrickville Metro and over 11,000 residences within a 1 kilometre radius of the centre. We live directly across from the Metro.

AMP Capital claims to be community focused and to have consulted with the local community. However, in reality and having been one of the people they spoke to (through Elton Consulting) the information gathering they did was completely false. When I spoke with the consultant they advised me that AMP planned to go up one level (not 5) and that we would not have a lot of our view altered from what we currently see due to this. They also advised that they would be using the space across from the Marrickville Metro between Edinburgh and Smidmore St for a market and community space. You can imagine my relief on hearing this and felt content to allow the progress of the centre to take place until the reality hit me when I read that they planned to be as big as Broadway!

The reality of this corner of the inner west is that we have vibrant streets in Enmore and King Streets and Marrickville Road. There are rarely any empty shops and people come from far and wide to shop in this unique area. In essence these streets are our "mall" and no major shopping centre is required. I won't lie, it is handy to have Woolworths and K-Mart across the road and I shop there and enjoy a relationship with many of the staff who work there. I do believe Marrickville Metro could do with revitalization (as AMP calls it) but that would be making the shopping centre more vibrant, modern and community friendly. If I really wanted a big mall (which isn't often) I don't have far to go for Broadway, Westfield Burwood or the city. I feel this is just a case of AMP making a grab for profits regardless of the concerns of their neighbours. I would like to know how many of the power brokers live in Marrickville or the inner west.

One of the key details that should impact on your decision is the fact that our own Mayor and Council do not agree with the redevelopment. Mr. Iskandar even attended a recent protest to voice his concerns with the rest of the community. Marrickville Chamber of Commerce have ordered 100 banners to be displayed along the shop fronts along Marrickville and Illawarra Roads. Marrickville Council will also be flying banners from each of its town halls in Newtown, Marrickville and Petersham, proclaiming the council's opposition to the Metro development. If

our own council disagrees with this redevelopment why does AMP insist on continuing it in its current form?

AMP's proposal for a shopping centre more than twice the size and height of the current Marrickville Metro is not in sympathy with the surrounding built environment (three sides of the existing centre are largely Federation and post-Federation cottages). Our single lane residential streets were never intended to cope with the current shopping centre, let alone one that is double in size and is projecting to attract approximately 5 million shoppers per year.

AMP's traffic study has identified that traffic will increase by a minimum of 50%. At peak times projected traffic increase is more. **The report says that the surrounding roads are currently already at maximum capacity.** Currently peak traffic brings surrounding streets to gridlock. The projected increase in traffic will seriously affect many streets in Newtown, Enmore, St Peters and Sydenham in addition to the streets around the Metro shopping centre.

We also have grave concerns about the increase in air pollution and litter this new redevelopment will bring. Living across from where the cars will drive up to each new level of the redevelopment absolutely concerns me. I have a 2 year old child and fear he will be living in an even greater polluted area than he currently does.

Living on the same street as the Marrickville Metro and in a cul-de-sac can be quite frustrating, especially on the weekends. People currently park over our driveway partially or completely, leave their litter behind, keep their cars running while they do their little shops, double park, beep their horns and generally show little respect for the people living across the road. How much will this increase after the redevelopment?

Expanding Marrickville Metro shopping centre by an additional 35,505 square metres means:

- More than doubling current retail space and more than doubling the current building height
- 4 million extra shoppers each year
- More cars and trucks clogging local roads
- More noise and air pollution
- Devastation of our local shopping villages and businesses
- Parking problems for local residents
- Privatised community space

Very few people in the Marrickville area are happy about this proposal now that we understand it's full scale. As a local resident of course I am against it but I also see how this redevelopment will change the whole dynamic of this area. As in the 80's we saw so much character leave Sydney for "progress and profits" and right now I feel we could potentially see the end of the inner west as we know it.

I am urging you to save Marrickville from this albatross around our community's neck and not allow this project to go ahead.

#### Dear Ms Tebbut

I am writing to you regarding the proposed development of the Marrickville Metro shopping centre, Major Project MP09\_0191 – 34 Victoria Road, 13-55 Edinburgh Road and part of Smidmore Street, Marrickville. I recognise that you are committed to the welfare of the Marrickville community, and I wish to express concerns about this development from three different perspectives; as a concerned resident of Marrickville, as a concerned citizen of NSW, and a concerned inhabitant of the planet Earth. I will address you from all three perspectives;

#### As a resident of Marrickville;

I recently discovered plans by the company AMP to expand the Marrickville Metro shopping centre to twice its current size- making approximately 44,000 square metres. According to their plans, they wish the mall to obtain town centre status, with an extension of opening hours, the addition of restaurants and entertainment, and the addition of clothing outlets etc, etc. I have several objections I would like to raise to this, as a resident of the proposed development site.

1) According to the submitted Environmental Assessment Report, section 7.4: "The proposed development is considered to result in an increase in traffic generation... of 56.8%...". I find this completely unacceptable; an increase in traffic around this area will result in total gridlock. There are no plans to improve infrastructure to meet this dramatic increase, and no solutions have been proffered.

2) According to the submitted Environmental Assessment Report – section 5.7.2: a "do nothing" scenario on the Metro site will mean that "The community's retail needs will not be met." I find this assertion simply absurd. King St, Enmore Rd, Marrickville rd, Illawarra rd, Broadway Shopping Centre and the city CBD are all within 5-15 Minutes of the proposed site. All of these strips offer the widest choices available to consumers in our society, from boutique clothing stores to hardware, from butchers to tarot reading. I cannot see what consumer choice oriented justification could possibly exist for this expansion, and I can only conclude that the decision to expand is driven by profit rather than some genuine consideration for locally based community need. I propose instead that the mall will service residents from further outside the area; impacting on the local community without any benefit.

3) The Economic Impact Assessment funded by AMP stipulates that the impact of the proposed development on small businesses on Marrickville road would be insignificant, at around 5%. As someone who conducts research and is familiar with the flexible construction of this type of data, I find this minimal figure difficult to believe. Local businesses were devastated with the first development of the Metro, and will be again with this expansion.

4) The plans emphasise the community significance of the development. I would ask AMP to explain how a privately run business can operate a community site in consultation with the local community when they will not be held to account through democratic process.

5) There are no significant attempts to incorporate principals of sustainability within the design of the building. A grey water tank and a few solar panels do not cut the mustard.

According to the Draft Centres Policy, 2009;

1. Retail and commercial activity should be located in centres to ensure the most efficient use of transport and other infrastructure, proximity to labour markets, and to improve the amenity and liveability of those centres.

As a long term resident of the area, I cannot see how the expansion of a shopping mall with all of the congestion and issues that this will bring will improve the amenity and liveability of the centre.

2. The planning system should support a wide range of retail and commercial premises in all centres and should contribute to ensuring a competitive retail and commercial market.

I fail to see how the introduction of a shopping mall with all of the market dominating chain stores and large scale grocery giants (such as Coles and Woolworths, which dominate 80% of the grocery market) that it will bring will benefit competition. The damage to small business will further harm competition in the area.

# 6. Retail and commercial development should be well designed to ensure they contribute to the amenity, accessibility, urban context and sustainability of centres.

The proposal does not adequately address any of these points within its environmental or economic report. There is no reference to the unique urban context of Marrickville, and no recognition of the fact that a significant part of what makes Marrickville unique is it's shopping strips already in existence; shopping strips that will be harmed, not improved, with this development.

#### As a resident of NSW

I am alarmed by the lack of community consultation in this development application process. Planning has been going on for at least the last year, and the first time I even heard of the development was when I was alerted by a community group.

AMP claim to have engaged in community consultation. I live on the street location of the development, and I was never consulted. This puzzled me at first. I have since discovered from other residents, that consultation activities such as door knocking were conducted during working hours, when few people were at home, or conducted outside the immediate area; in Petersham and Lewisham. These areas would not be adversely affected. The consultation process appears to have gone askew. Considering that the consultation process was funded by the investor; why am I not surprised?

This point illustrates my wider concern about NSW politics in General; with the introduction of legislation such as the Environmental Planning and Assessment Amendment Bill 2008 that lessen the influence of local residents on the planning process, and the prevalence of development cases (such as the new Iron Cove Bridge) that bypass local council approval. I am deeply troubled by this situation. No-one is better positioned to understand the needs of communities than their local community representatives and their councils. I deplore this disregard for the right of people to ownership of development within their own communities. The unequal relationship between developers of massive projects (who can fund 'independent' economic analysis to send to the State government) and local residents (who cannot) further exacerbates this lack of community control.

If you were to ask the residents of Marrickville what they wanted for their community, you might get a variety of answers; assistance for small business, improvements to cycleways and public transport, more community spaces, more affordable housing and greater emphasis on sustainability would certainly feature. I doubt very much that a massive shopping centre development would be the

foremost of their desires. I am a local community member, and it is certainly the opposite of what I would like to see.

As a final point, I would like to say that the NSW Government has come under significant scrutiny over the last few years for the relationship between property developers and the Labor party. Political donations and slimy backroom deals have left a bad taste in the mouths of voters. Since 1999 companies for whom former Labor MP Graham Richardson had lobbied – Medich Property Holdings, the Walker Group, Bradcorp, and Hardie Holdings -- have collectively donated \$1,400,647 to the NSW Labor Party (\$278,400, \$451,517, \$385,030 and \$285,700 respectively).

Excuse me, but NSW is getting tired of this laundered corruption. Decentralisation of planning power would be appreciated, thankyou.

#### As a concerned inhabitant of the planet Earth

With our Earth's resources rapidly dwindling and a garbage soup the size of the USA whirling around in the centre of the Pacific, we cannot afford to continue on with our attitude of business as usual. Furthermore, studies have demonstrated that despite the relentless march of consumerism, and the wealth generated by our exponential production and constant economic growth; we are no happier than we were 50 years ago.

Put simply...

THE WORLD DOES NOT NEED ANOTHER SHOPPING MALL ..

And Marrickville, as part of the world, does not need one either.

Thanks yet again for your e mail.

As I have said repeatedly now I do not share your views on the issue.

You have however made certain allegations of corruption that I suggest you lodge with the ICAC if you seriously believe this to be the case.

In terms of council deciding to make an allocation of funds for the campaign to prevent the expansion and your assertion that its just 32 residents who oppose it. I assert that you are once again wrong. It is well above 32 residents who oppose the proposal, as well as all small business operators in our LGA.

The residents around the Metro are the most affected residents. Even if it were 1 resident objecting and those objections are legitimate then those concerns are legitimate. To date only 1 person (you) has contacted me in Favor of the further development of the Metro site, I have at least 50 resident submissions opposing it. None of those residents have expressed concern about Metro in terms of the swimming pool. They all object to increasing the amount of traffic in their streets (and other problems).

In terms of referring to lifestyle choices – I was talking specifically about your submission for convenient shopping outweighing the permanent effect the development will have on residents living around the development.

You can check whether I was at the meeting or not by calling the council, so its not a moot point. The newspapers get it wrong all the time.

Council is entitled to commission reports and it has done so via allowing the mainstreet committee to give \$3000 to the Chamber of commerce. The funding for the mainstreet committee is 50% Commercially zoned properties and 50% council funds. The purpose of the Mainstreet committee is to support the small shopping strips. The report being commissioned to assess the impact of the Metro on small businesses. The aims of the Chamber and of the mainstreet committee on this issue are identical – it doesn't matter whether the mainstreet committee or the Chamber carry out the report from a representational point of view.

The Metro expansion is not permissible when considering the planning laws that exist, why should AMP be exempted from the planning laws. No other person, company, corporation or business can get a rezoning on those lands – why should they be allowed to? Are they special? There are commercially zoned areas, commerce belongs in those zones. Metro is bigger than it should be, there is inadequate infrastructure in terms of roads to that area, expanding it will make things worse. When talking about being Fair minded and giving all of us a fair go I am very clearly referring to the fact that Metro and AMP are being given a massive financial advantage by not being expected to comply with the rules that exist for everyone else.

Finally spare me your indignation, you wrote to me making an allegation that I was behaving in a corrupt manner (amongst others), yes I find such assertions ridiculous and quite offensive.

In summary I do not agree with your views that shopping convenience of some comes before:

- the well being or residents who live around metro
- The shopkeepers and shop owners of the Marrickville LGA

Thank you for your e mail although I do not share your views on this topic.

You may not be aware but the lands around the Marrickville Metro site were categorized category A industrial lands by the state government in its metro strategy a few years ago. This category was given to Industrial Lands that were considered so significant that they could not be rezoned for any other use except for Industrial use.

Commercial uses such as Marrickville Metro style retail is specifically prohibited in such zones. In the same document the government also announced that it would consider changing the zone from category A lands only if the interested party was the owners of Marrickville Metro. In essence what they were saying is that purchasers of these lands were not on a level playing field and that the owners of Marrickville Metro were being given a massive advantage in the purchase of these lands. This is the only site that I am aware of that is being treated in this way. Sound dodgy? It does to me.

I find it disgraceful that any government would categorize lands as type A industrial for everyone else except for a major corporation with heaps of cash. Obviously something isn't right here and smaller players are not being treated with the same equality as larger players.

In the election campaign 2 years ago, I ran on a platform that clearly stated that I would support small family businesses that are in existing commercial areas. I have also said repeatedly (prior to the last election) that I would in no way support an expansion of Marrickville Metro as it would be detrimental to small businesses in the area who have gone and purchased in existing retail areas and are now being placed in an unfair and grossly disadvantaged position commercially.

I too would like to be given the option of buying property knowing that the government would rezone the land that I purchase would be rezoned in a very favorable manner to me in a commercial sense. However the same advantage is not afforded to me or any other individual, company or corporation. I will not under any circumstance support an expansion which I believe is wrong, detrimental to the public interest and that stinks to high heaven.

Thank you for your e mail although I do not share your views on this topic.

You may not be aware but the lands around the Marrickville Metro site were categorized category A industrial lands by the state government in its metro strategy a few years ago. This category was given to Industrial Lands that were considered so significant that they could not be rezoned for any other use except for Industrial use.

Commercial uses such as Marrickville Metro style retail is specifically prohibited in such zones. In the same document the government also announced that it would consider changing the zone from category A lands only if the interested party was the owners of Marrickville Metro. In essence what they were saying is that purchasers of these lands were not on a level playing field and that the owners of Marrickville Metro were being given a massive advantage in the purchase of these lands. This is the only site that I am aware of that is being treated in this way. Sound dodgy? It does to me.

I find it disgraceful that any government would categorize lands as type A industrial for everyone else except for a major corporation with heaps of cash. Obviously something isn't right here and smaller players are not being treated with the same equality as larger players.

In the election campaign 2 years ago, I ran on a platform that clearly stated that I would support small family businesses that are in existing commercial areas. I have also said repeatedly (prior to the last election) that I would in no way support an expansion of Marrickville Metro as it would be detrimental to small businesses in the area who have gone and purchased in existing retail areas and are now being placed in an unfair and grossly disadvantaged position commercially.

I too would like to be given the option of buying property knowing that the government would rezone the land that I purchase would be rezoned in a very favorable manner to me in a commercial sense. Charmaine,

Thanks yet again for your e mail.

As I have said repeatedly now I do not share your views on the issue.

You have however made certain allegations of corruption that I suggest you lodge with the ICAC if you seriously believe this to be the case.

In terms of council deciding to make an allocation of funds for the campaign to prevent the expansion and your assertion that its just 32 residents who oppose it. I assert that you are once again wrong. It is well above 32 residents who oppose the proposal, as well as all small business operators in our LGA.

The residents around the Metro are the most affected residents. Even if it were 1 resident objecting and those objections are legitimate then those concerns are legitimate. To date only 1 person (you) has contacted me in Favor of the further development of the Metro site, I have at least 50 resident submissions opposing it. None of those residents have expressed concern about Metro in terms of the swimming pool. They all object to increasing the amount of traffic in their streets (and other problems).

In terms of referring to lifestyle choices – I was talking specifically about your submission for convenient shopping outweighing the permanent effect the development will have on residents living around the development.

You can check whether I was at the meeting or not by calling the council, so its not a moot point. The newspapers get it wrong all the time.

Council is entitled to commission reports and it has done so via allowing the mainstreet committee to give \$3000 to the Chamber of commerce. The funding for the mainstreet committee is 50% Commercially zoned properties and 50% council funds. The purpose of the Mainstreet committee is to support the small shopping strips. The report being commissioned to assess the impact of the Metro on small businesses. The aims of the Chamber and of the mainstreet committee on this issue are identical – it doesn't matter whether the mainstreet committee or the Chamber carry out the report from a representational point of view.

The Metro expansion is not permissible when considering the planning laws that exist, why should AMP be exempted from the planning laws. No other person, company, corporation or business can get a rezoning on those lands – why should they be allowed to? Are they special? There are commercially zoned areas, commerce belongs in those zones. Metro is bigger than it should be, there is inadequate infrastructure in terms of roads to that area, expanding it will make things worse. When talking about being Fair minded and giving all of us a fair go I am very clearly referring to the fact that Metro and AMP are being given a massive financial advantage by not being expected to comply with the rules that exist

for everyone else.

Finally spare me your indignation, you wrote to me making an allegation that I was behaving in a corrupt manner (amongst others), yes I find such assertions ridiculous and quite offensive.

In summary I do not agree with your views that shopping convenience of some comes before:

- the well being or residents who live around metro
- The shopkeepers and shop owners of the Marrickville LGA
- The right that we are all afforded the same advantages in life
- That for shopping convenience we create a new classification of land use that apply for everyone except the massive corporations of Westfields and AMP

I have no problems with strip shopping and yes I do support small business over massive franchises. As such I see no problem with council providing financial assistance to cash starved shopping strips, Metro has clearly got enough cash to influence government policy on this issue – I have no problems denying them a further \$3000.

You may not be aware but the lands around the Marrickville Metro site were categorized category A industrial lands by the state government in its metro strategy a few years ago. This category was given to Industrial Lands that were considered so significant that they could not be rezoned for any other use except for Industrial use.

Commercial uses such as Marrickville Metro style retail is specifically prohibited in such zones. In the same document the government also announced that it would consider changing the zone from category A lands only if the interested party was the owners of Marrickville Metro. In essence what they were saying is that purchasers of these lands were not on a level playing field and that the owners of Marrickville Metro were being given a massive advantage in the purchase of these lands. This is the only site that I am aware of that is being treated in this way. Sound dodgy? It does to me.

I find it disgraceful that any government would categorize lands as type A industrial for everyone else except for a major corporation with heaps of cash. Obviously something isn't right here and smaller players are not being treated with the same equality as larger players.

In the election campaign 2 years ago, I ran on a platform that clearly stated that I would support small family businesses that are in existing commercial areas. I have also said repeatedly (prior to the last election) that I would in no way support an expansion of Marrickville Metro as it would be detrimental to small businesses in the area who have gone and purchased in existing retail areas and are now being placed in an unfair and grossly disadvantaged position commercially.

I read in the Inner West Courier today that council unanimously voted to give the Marrickville Chamber of Commerce \$10,000 to fight the expansion of this much needed shopping centre.

Marrickville Metro is the only shopping centre for some distance in this area. It is overcrowded, with not enough parking, simply because of the sheer numbers of people it has to service. People from Marrickville, Newtown, Erskineville, St Peters, Alexandria, Stanmore and Petersham all shop here.
