I strongly oppose the application based on the following points: 1. It is a gross <u>overdevelopment</u> of a region of the Shire which is already has the considerable pressures of the Breen/Australand development just down the road to contend with.

2. The 16 storey maximum building height is way above any other structure in the vicinity and will, as a result, be a visual eyesore and blight on the landscape from all directions. The isolated location of this development will only exacerbate this effect as the eye is drawn to it whether seen from the bay or from residences in Woolooware.

3. The massive increase in traffic volumes is a major concern. As reported by The St George & Sutherland Shire Leader, 25/10/11, "intersections to the west of the leagues club are already at or above capacity". From personal experience I know to avoid the Captain Cook Drive-Taren Point Road intersection on week day peaks and weekends since waiting through 1 or 2 phases of traffic lights is a mere formality at this time. I can't imagine what it will be like when the new Green Hills suburb comes on line. Another 700 dwellings at this development definitely won't help. I'd hate to be driving to Cronulla beach on a summers day from anwhere north of The Boulevarde.

4. Another 3, possibly 4 sets of traffic lights (if the Gannons Rd roundabout is removed, which would be likely with the increased traffic volume) along the 800m stretch between Gannons & Woolooware Roads. Between the Sharks residential development and Woolooware Road there would be 3 lights in a 400m stretch, effectively turning a great, quick stretch of road into a Kingswayesque nightmare of s top-start despair. Just what the people of the Shire, Sydney's beachgoing public and especially the residents of Kurnell, North Cronulla and Green Hills don't need. I feel sorry for those latter people most who's daily commute will take on new levels of stress and frustration. Somehow, I don't think a few new bike paths and an impressive public transport hub will alleviate the potential traffic headaches.

5. Impropriety. The Leagues Club was originally sold the land for the playing fields on the premise that this land remained for this type of public use. To develop this land and profiteer from the project is to renege on this agreement, plain greedy and is a disservice the community.

As developers and planners its easy to dream big and build these "Legoland" developments with such ideals as: improved facilities and services for all or, saving a beleaguered football club from financial ruin (even though they brought it on themselves). T he impacts (both positive & negative) of this scale of development will be felt for years to come by the community. As is obvious by my points listed above I think the negatives greatly outweigh the postives. I just hope those making the big decision can put themselves in the shoes of those in the community who will be most affected and see it from their perspective. And please leave football politics out of it.

Reason for Objection – Traffic Congestion

The proposed development is significantly larger than any other existing development in the Sutherland Shire. The surrounding roads could not cope with the additional traffic generated by 700 units, and a Shopping Centre, and an expanded club. Gannons Road and Captain Cook Drive are already severely congested at peak times, resulting in lengthy delays on both roads.

A traffic study included in the EA submitted by the developers, found the project would generate 1249 two-way vehicle movements an hour during the Friday afternoon peak period and 1060 vehicle movements during the Saturday afternoon peak period.

There is no room for the expansion of these roads, and the removal of the roundabout would worsen the traffic flow for this amount of cars. Imagine the impact when crowds arrive for both Saturday sport and Rugby League Games.

This increased traffic will stop children being able to walk and ride bikes to Woolooware Public School, Wooloware High School and Cronulla High, as roads will be too dangerous for pedestrians. Surely our children deserve the opportunity to be able to walk to school?

I strongly believe that proceeding with this development would be at the detriment of our local environment and community, and I ask that the objections expressed in this letter be noted during the planning process.

To Whom it may concern:

I am writing to express my support for the development proposed for the current site of the Sharks Football Club carpark and adjacent playing fields.

I was born in this area and grew up here; my parents now live in Cronulla and I am a long term resident of the Sutherland Shire. I have four children, three of them already old enough to secure part-time work to help support their school and university studies, however two of my three children have not yet been able to secure part time work.

Employment opportunities in this area are limited - as is housing. I'd love my kids to be able to afford to live in this area but with demand for housing high and costs rising, that's unlikely unless more housing is built. This development makes it more likely that my children can live in the area they grew up in, as I was able to do.

With an estimated 1500 new permanent jobs to be created - and likely corresponding increased economic activity in the area resulting - I see this development as providing great opportunities for the local region.

There's not a lot of shopping between Kurnell and Caringbah; while Cronulla Mall has lots of retail, the supermarket facilities and medical facilities are poor. This development will address these current deficiencies.

I have to say that while I'm often opposed to over-development in my local area, this particular proposal has a great community and environmental focus which I believe is a very positive thing. The parking and traffic options seem quite well thought out and the development is just a short walk from Woolooware railway station which adds amenity.

The housing options in this proposal are sound; It's a really desirable location, so close to the beach and to schools, and another advantage of

this proposal is that instead of shunting people out west to live in Sydney's food bowl, they can share in existing infrastructure, while bringing additional public transport that current residents can also benefit from.

Stormwater from the heavily-fertilised golf courses nearby currently leaks into the bay having travelled through the old tip. No wonder the ovals flood all the time. I think this proposal Is well thought out and will actually improve stormwater drainage and the state of the bay by filtering the water correctly before it is discharged - something that the Council is not currently taking care of.

I trust you will consider these points when making your decision about the approval of the mixed-use development proposal for the Cronulla Sharks land.

The development should be assessed on it's own merits separate from the financial affairs of the Sharks. We <u>object</u> to the proposed development in its current form due to:

- impacts on traffic - significant problems currently exist with traffic flows around and through the area. This will be significantly exacerbated by increased movement of workers and those living in the units. Need improvements to Gannons underpass, Captain Cook Rd east of the development, and guaranteed 7 day public transport to nearby hubs. This is especially relevant considering the residential developments at Australand and Breen holdings near Cronulla high which will further increase traffic flows.

Although < 10 days per year, sign ificant planning also needs to be undertaken for game days. There is also no provision for parking during sporting events taking place at playing fields adjacent to development who previously used those spaces next to the junior RL fields.

- visual pollution - 50+metre 13 storey waterside tower blocks is a eye sore, combined with the clumping of residential blocks creates a mini Hurstville or Chatswood.

- less objection to the retail component if traffic issues are addressed
