Dear Mr Woodland

I have recently reviewed the above Concept Plan proposed by Cronulla Sharks and wish to convey my full support for the development.

My family resides less than 1 kilometre from the proposed development and we would welcome access to improved infrastructure such as a medical centre, shopping centre, child care, picnic areas, playgrounds and a revitalised leagues club and entertainment precinct.

The proposal outlines environmental benefits arising from the incorporation of world leading environmental practices, in particular with regard to the health and protection of the vital mangroves ecosystem located on the Botany Bay foreshore.

The Sutherland Shire requires additional medium and high density housing in the short term. On the 24th of November 2008 Sutherland Shire Council (**Council**) published report number SDC004-09 titled "Draft Housing Strategy Part 1 – The Importance Of Housing Policy". The report was the first stage in the adoption of a housing strategy which will guide housing supply in the Shire until 2031. The following extracts from the report clearly illustrate the need for future development of medium and high density housing.

Smaller household sizes mean that more dwellings are required to house the same population as there are less people living in each dwelling. The fact that there was an increase of 2,494 dwellings over the 5 year intercensual period yet the total population decreased by 1,015, highlights the impact of decreasing household size. It means that there will be a steady demand for more dwellings as the numbers of households grow, even if there is no population growth.

A 5% population growth target to 2031 would require provision being made for 14,080 new dwellings within the new LEP. Given that there is capacity within existing zones to provide for 10,100 new dwellings, a 5% growth strategy would **require provision to be made for further 3,980 dwellings**.

Accommodating growth will require a review of the potential of each centre in Sutherland Shire, particularly those serviced by railway stations. Housing supply can be enhanced through revising floor space ratios and building heights to deliver more dwellings within existing zones, or zone boundaries can be changed to provide more opportunities for higher density development. Given that choosing appropriate strategies will raise complex and emotive issues with affected communities, it is recommended that Council initially adopt a 1% growth strategy as the basis of its new Local Environmental Plan.

Other demonstrable community benefits arising from the proposed development include:

- The creation of 1500 new jobs;
- Supermarkets, medical facilities and child care in one convenient location;
- Relocation of existing sporting fields to new, state-of-the-art facilities within a couple of kilometres:
- Improved public transport via a new dedicated public bus service to the precinct;
- Easier access to sporting events via Park and Ride arrangements from satellite parking locations which, subject to patronage, could reduce traffic congestion during Sharks game days; and
- Increased community support and commitment from local residents and fans of the Cronulla Sharks football team.

I wish to lodge an objection to this proposed development MP 10_0229 - Concept Plan - Mixed Use Development, Cronulla Sharks

The scale of the development is, in my opinion, too large for the local area. It will dwarf all other buildings in the region and it is unnecessary to build to this height. We would set a dangerous benchmark against which other develops could push to match.

It seems to be overkill to consider constructing 700 units in towers up to 16 storeys high PLUS a Retail development PLUS expanded Sharks club and grounds. This is the equivalent of building an entire new suburb without the supporting infrastructure. A development that is equivalent to half the building height and half the number of units would be more appropriate for the area.

While the project may bring additional housing to the area, there is nothing to suggest that this will be at anything other than market value, and that is still not affordable housing for young families.

There also appears to be significantly insufficient transport infrastructure in an area already congested, especially on weekends and match days. The current proposal of 700 units equates to an additional 1000 cars per day. The retail precinct would most likely attract double that. The Club and grounds would attract up to 3000 extra cars for special events and game days. This puts significant stress on local infrastructure and creates a traffic hazard in itself. This precinct would require its own bus service and this should be negotiated with govt authorities prior to this development being considered
