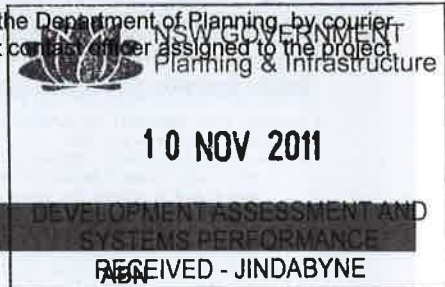

  2. the Perisher Village complex in five stages comprising:
    - seven buildings identified as Buildings A,B,C,D,E,F & G accommodating 239 apartments, 5,055msq of retail floor space and 2,746msq of commercial/recreational facilities; and
    - pedestrian plazas and pedestrian bridges; and
    - basement car parking; and
    - associated supporting infrastructure including roads, car parking, and Perisher Blue workshop location;
  3. demolition of the existing NPWS building at Perisher Valley and the existing Perisher Blue Workshop at Smiggin Holes and;
  4. landscaping and rehabilitation.
