I write to you to voice my deep concern relating to current and proposed developments close to the homes of a large number of Manly residents including my own. (Unit 537/25 Wentworth St Manly NSW 2095) In particular I would like to address many proposed Royal Far West development MP10-0159

The proposed development of the site with high density accommodation will increase demands on infrastructure in the area which is already over stretched

There is already insufficient traffic management in Manly to deal with the current load let alone with the addition of high density accommodation, restaurants and cafes.

It is not unusual for us to queue in traffic merely to enter our own car park. We have one parking space for our two cars and it is almost impossible to get parking in the area when we need it most- weekends. Our guests avoid seeing us on weekends to avoid the traffic hassles and inability to park. Addition of a massive development like this will only make it worse.

In recent years Manly has slowly improved as a place to dine and enjoy a night out in peace and safety. The village feel has improved and the reputation as a drunken and dangerous destination slowly declined.

Content:

1) The scheme is too tall - the buildings of a comparable height nearby are also too tall in relation to the overall streetscape

2) The plan does not consider sufficiently the impact on traffic & parking, certainly at w/ends when usage is high; also

what will happen once the Steyne is pedestrianised? (cf Manly 2015)

3) The plan only nods towards environmental concerns. The environment makes Manly, which otherwise has little of building interest. As a public sector building, the RFW must assume leadership Why couldn't the building be carbon neutral? Why can't the plan aim for a 5 or 6 star green rating? Particularly poignant given the buildings location opposite the ocean.

4) Though professionally d one, the new scheme is intensely boring to look at. The redevelopment poses a once in a lifetime opportunity to have a world-class building on an iconic site in a key centre of Sydney. Why can't we at least aim for a Pixel building in Melbourne or an Aqua Tower in Chicago - these new buildings inspire, engage; they reignite the locality and attract interest, tourists and hotel guests. This scheme offers little of interest and makes no reference to the site's location right opposite Manly beach and the Pacific Ocean. The building's existing presentation (onto the Steyne at least) is detrimental to the area but why should we repeat lessons from the past? Surely we can raise our game, apply some vision and leadership and build a stunning complex worthy of the site? Maybe then you might even find tourists come to look at the RFW rather than ignore it completely, which is what happens and what I fear will happen.
