I wish to record my objection to the proposed Cronulla Sharks Development MP 10-0229, 461 Captain Cook Drive Woolooware

The proposal to rezone the junior playing fields of the Cronulla Caringbah Rugby League grounds adjacent to the Toyota Stadium would be a disaster. The Shire is short of playing fields as it is even with the proposal of ten new fields to be commissioned at Kurnell over the next ten years. To build 700 high rise units on that site would be inappropriate. Open space is very important to our district. There are other more appropriate sites to build upon which are close to transport. The notion that this development will save the Sharks is ridiculous. Everyone knows that the Sharks will soon be relocated to the Central Coast. Surely the Planning Panel will make a decision based on sound planning principles and not on sentiment. Even the proposal of a large shopping centre seems over the top. Cronulla has already got two supermarkets with a new one soon to be commissioned which will make three. Caringbah has three grocery stores with a large Franklins at Taren Point. We are well serviced with stores. Medical centres are also in abundance. The club premises should be redeveloped for tourist purposes being located on the road to Kurnell and Cronulla.

I have lived in Caringbah for 60 years and always understood that the area around Toyota Stadium was to remain zoned as open space, being next to sensitive mangroves and on a tip site.

If the planning panel is to rezone this site then there should be no more than three storeys which would be in keeping with other constructions nearby. But I do believe that this area is unsuitable for residential development and should be refused. Parking and traffic is already a problem around the district. Those junior grounds are used constantly throughout the year for parking to facilitate any number of events. Where would people park if this option is removed? You can bet that the visitors of the 700 proposed units would end up parking across the road on the small parking area which is used by the patrons of those sports fields. Any way you look at this proposal it seems amazing to me that it has come this far. Mr Kelly the previous planning minister should have knocked it on the head immediately.
