Dear Mr Brown and Mr Woodland,

I am emailing you because I have huge concerns about the proposed Cronulla Sharks Development, 461 Captain Cook Drive, Woolooware (MP 10_0229).

While I can see that the Cronulla Sharks need to do something to escape their financial difficulties, most of their proposal seems to be extremely selfish. They are only concerned with their own needs and do not seem to be not considering the bigger picture, ie the wants and needs of the local community that supports them, both now and hopefully in the future.

I object to the proposed development in the strongest possible way - mainly because of its height and size and the impact that it will have on the local community.

I am listing my objections more specifically below.

TRAFFIC CONGESTION

A traffic study included in the EA submitted by the developers, found the project would generate 1249 two-way

vehicle movements an hour during the Friday afternoon peak period and 1060 vehicle movements during the

Saturday afternoon peak period. Gannons Road and Captain Cook Drive are already at gridlock in peak times!

There is no room for expanding these roads – they are surrounded by schools, sporting fields, mangrove

ecosystems and a railway line. The proposed installations of 3 sets of traffic lights along Captain Cook Drive would mean

absolute standstill every morning and afternoon. Please come for a drive along Captain Cook Drive and try to turn into Gannons Rd in the afternoon peak hour and see for yourself.

All this, with another new suburb being created at the back of Wanda right now. This increased traffic will stop children being able to walk and ride bikes to Woolooware Public School, Woolooware High School and Cronulla High, as roads will be too dangerous for pedestrians. Surely our children deserve the opportunity to be able to walk and ride to school?

PARKING

Where will the residents of these 700 units park? The proposition includes just over 1.2 parking spots per unit, however as this complex is not in walking distance of a train station the average car ownership will be one car per person, per dwelling. This would be result in 2 - 4 cars per unit. There is no parking on Captain Cook Drive or Gannons Rd and this would force cars to park not only in surrounding residential streets, but the public car parks for the surrounding soccer and rugby league fields, Solander and Captain Cook, impacting on local parents & sporting teams taking their kids to both weeknight training as well as weekend games.

LOSS OF PLAYING FIELDS

The Sutherland Shire has minimal land designated for kids sport and outdoor activity. Current playing fields all over the Shire are used to maximum capacity for Soccer, Rugby League, Oz Tag, and Cricket, making open spaces even more valuable. My sister is registrar of Lilli Pilli Soccer Club, and I know first hand about the difficulties they've experienced finding venues for games. And they're only one club in one sports code. Add all the rest and the problem multiplies significantly. It is madness to allow fields to be taken away.

This land is badly needed to provide future generations with fields to maintain healthy habits, community spirit in amateur sport. Its hypocritical of The Sharks Club to say they are doing this for the community, when they are taking so much away. These fields were always designated for Junior Sport. Not Development.

The Developers are justifying their position by saying sporting fields will be reallocated at Cronulla High School. The NSW Education Department has reached NO AGREEMENT on this.

SIZE & DENSITY

The proposed development is significantly larger than any other existing development in the Sutherland Shire. The surrounding roads could not cope with the additional traffic generated by 700 units, a new shopping centre, and an expanded club.

This high-density development will completely change the look, feel and landscape of the area. Nothing this size is located so far from public transport. Also, this monstrous development will cast a massive amount of shade over a large area and stand out as eyesore that's visible for kilometres around. It will destroy the open suburban feel we have all strived to maintain, and pay a premium for, in the Sutherland Shire.

I'm surprised that the powers that be are even thinking about building such tall buildings so close to children's schools and sporting fields. We have a duty of care to our children above all.

SURROUNDING ECOSYSTEMS

Cronulla Sharks is located in close proximity to mangroves and to Towra Point. The mangroves are an important breeding ground and hatchery for marine and bird life. Birds also migrate to Towra Point from thousands of kilometres away to breed and raise their young in safety. Can you guarantee that this development will not have negative impact on them? I don't think so.

LOSS OF GAME DAY PARKING

The Sharks football games have long been a favourite outing for Sutherland Shire residents. Families and fans enjoy the local atmosphere, and being able to park close to the stadium and walk to the field. I object to the proposition of offsite parking, and the proposal of mass parking at Wanda Beach and buses being used to transport people to and from their cars. There is nowhere near enough parking available at Wanda Beach for a start. The extended travel times with buses, the hassle, and no doubt impossible for families will turn the average Sharks supporters away and would make thingsalmost them and disembarking from them would have a significant impact on residents at Wanda. As would the mess they leave behind.

If buses are not used, the impact on local residents of North Caringbah, Woolooware, and North Cronulla would be unacceptable. Cars would be forced to park in residential streets, on peoples front lawns etc, creating added impact to the already congested situation caused by the units. I also object to local schools' playing fields being used for car parks. This is a dangerous precedent. We rely on our school sporting facilities to be kept in good condition for sport for our kids, not parking lots! What happens when people start suing our local council for the cost of injuries caused by car damage to school sporting fields?

INFRASTRUCTURE

Do our kids' schools have the capacity for the 400 families at Wanda AND another 700 units? As many of the units have either 2 or 3 bedrooms, it would be naive to imagine they would all be tenanted by adults alone.

Will Cronulla Police Station be enlarged and upgraded to cater for the huge influx of residents if the project (or even part of it) goes ahead? It's already way too small to cater for our community now. And Miranda Area Command has more than enough on its plate too. I waited half an hour just to speak to someone there last Friday evening. This is not a complaint - just a statement of fact.

I am happy for my objections to Cronulla Sharks Development (MP 10_0229) to go wherever they need to go, but PLEASE REMOVE MY NAME FIRST.
