- (2) otherwise provided by the conditions of this approval.
- Insert the following new condition B14 after condition B13:

B14 Plan Amendments

To ensure that appropriate landscaping is provided for the development, an amended landscaping plan is to be prepared detailing embellishment to all elevations of the multi-deck car park, including the separation between the multi-deck car park and existing Clinical Services Building. The amended landscaping plan is also to demonstrate the retention of existing mature trees north of the revised location of the multi-deck car park. Details are to be provided to the satisfaction of the Certifying Authority prior to the issue of a Construction Certificate for the multi-deck car park and forwarded to the Department of Planning and Infrastructure for their records.

• Insert the following new condition B15 after new condition B14:

B15 Bicycle Parking

Prior to the issue of any construction certificate for works associated with the entry building, the public bike storage/parking approved at Level 1, adjacent to the approved medical records room and on-grade parking, is to be relocated to a suitable location of similar size and capacity. Details are to be provided to the satisfaction of the Certifying Authority and forwarded to the Department of Planning and Infrastructure for their records.

Insert the following new condition E7 after condition E6:

E7 Use of the Temporary Car Park

Prior to the issue of an occupation certificate for the multi-deck car park, use of the temporary car park is to cease operations and is to be restored to its original state 3 months following the issue of the subject multi-deck car park occupation certificate. Details are to be provided to the satisfaction of the Certifying Authority and forwarded to the Department of Planning and Infrastructure for their records.

• Insert the following new condition F5 after condition F4:

F5 Use of the Temporary Car Park

Use of the temporary car park is restricted up until the completion of the multi-deck car park and the issue of an occupation certification relating to the use of multi-deck car park.
