From what we have read in the proposal, we have concluded that we absolutely do not support this! Our reasons and comments are below.

We feel our quality of home life will be sacrificed to an overrated development and expensive venture. There are already too many developments in this small area and we are affected by each and every one of them.

Therefore, WE OPPOSE THE CURRENT SHARK PROPOSAL!

Comments:

I live in a street that backs onto Capt. Cook Drive. We have been fighting for the past 10 years+ over the noise pollution generated daily. The Shark Park Development would put the last nail in the coffin for this community. I have seen the Environmental Traffic Report which I believe is in fact only benefiting the clubs efforts to get this approval. I have a copy of the report done by McLaren Traffic engineering (same company that has completed the current report) from 1999.

It states that, "Traffic flows - Recent 1999 RTA published data shows that the Annual Average Daily Traffic along Capt. Cook Drive, west of Gannons Road was 36,052 vehicles per day. In 1996, the AADT recorded at this same location 32,144 vehicles per day. The resulting compound growth rate is 3.9% per annum. Previous intersection counts were undertaken on Thursday 21st Sept 1995 between 7am and 3pm at the junction of Capt. Cook drive/ Woolooware Road North, which revealed a peak period from 7am to 8am although the late afternoon commuter period was not observed.

The survey indicated peak hourly flow of 477 vehicles in Woolooware Road North. This equates to a daily traffic volume 4800 to 6000 vehicles. A marginal growth rate of 0.5%

The 7am to 8am peak hour volume within Capt. Cook drive, west of Woolooware North was 1607 vehicles. This equates to a daily volume of 16000 to 20000 during peak hours.

It was stated on the "The Leader"[dated 11/10/11] estimated 1249 vehicles during peak time at current reports dated 2011. There is a difference an discrepancies between these reports. Needs further investigation.

I would like to question the figures from their (McLaren Traffic engineering) report made in 1999. These figures just don't add up. I can assure you traffic has only increased not decreased as these reports seem to suggest. We have 1000+ trucks movement daily not including regular cars. There is nothing in the report made on traffic management that adds these to the equation.

Our main concerns are about the increase traffic during and after the development is completed. The amount of parking of 600 approx. will not cover anywhere near what they are expecting on game days to attract max. crowds for games and visitors to the complex. Where will the overflow go? Every home game, our street is filled to capacity. In most cases, there not enough room for our own cars. At this stage they are not receiving crowds as they would if they were on a winning streak. What will happen when the Sharks are peaking at their best? The amount of mess neighbours have been complaining about left in their gardens and driveways is unbelievable . We are left to clean up everything! This is not warranted.

My husband and I moved to the Shire 25 years ago as newlyweds for a better life. We have noticed, more so, in the past 10+ years our lives are more invaded by traffic 24/7. Our backyard is more of a NO GO zone. At present, we are on the Noise Abatement List, but as always there is no money. When a new development is usually approved, infrastructure is put into place to protect residents from suffering at the hands of the development. The Shark Park development should have an obligation and responsibility (at some degree) if they are to inflict more traffic, noisy crowds and the takeover of our streets.

I compare the amount of noise and traffic to living at Port Botany. I have

read in their local paper the amount of assistance the Mayor has done for the residents in reducing truck movement. But here in the Shire we have been left to just accept whatever comes our way.

This is very poor and unfair! We pay rates and taxes like everyone else and we just want a peaceful home life. However we have been robbed of this time and time again.

This is also just a way to try and save a doomed club, but this is at the expense of the vulnerable locals.

The residential section even meets Sutherland Shire Council long-term policy direction promoting the need for further mixed-use, high-density development within the Shire and will help meet the stated council goal "To maintain growth in business and employment, the Sutherland Shire needs to increase its population by at least 5% over the next 20 years, requiring at least an additional 14,070 new dwellings in the area."

The Sutherland Shire Councils own housing strategy as in the 2009/2010 Annual Report targeted ten suburbs as key local districts for development; Caringbah and Woolooware are two of these. The councils own report suggested 4 levers to increase local housing supply, these are:

- Change zonings to high density

- Change floor space ratios

- Increase height limits

- Remove barriers to development
