INVITATION TO ATTEND OUR COMMUNITY CONSULTATION EVENTS FOR THE SUMMER HILL FLOUR MILL PROJECT

On behalf of EG Funds Management I would like to take this opportunity to forward to you our second newsletter for the Summer Hill Flour Mill Project and invite you to attend one of the consultation events that we will be staging in May 2011.

The consultation events form part of the second phase of our engagement process and have been designed to test community attitudes to the Concept Plan that is being advanced through the NSW Department of Planning and Infrastructure to guide the redevelopment of the Flour Mill Site into a vibrant mixed use precinct.

In March 2010, EG Funds Management asked the Summer Hill Community whether it was time to consider a change in land use on the Flour Mill Site. We commissioned a community survey to determine the level of support for changing the use of the Flour Mill Site from industrial to a mixed use development offering a range of residential, office and retail uses set in landscaped open space with a strong connection to the proposed Lewisham West Light Rail Station. The survey results indicated overwhelming support to changing the industrial use of the site with 82% of respondents preferring that the site not be retained for industry.

We are aware of the interest that you hold in the future of this site and we are committed to advancing a Concept Plan that responds to its unique industrial heritage, complements the adjacent McGill Street Precinct, supplements the open space network created by the Greenway corridor and supports a viable light rail system to service the inner west.

In May 2011, EG Funds Management will be hosting two consultation events that have been designed to enable you to fully understand the Concept Plan and provide comment directly to our design team.

These events are:

- Stakeholder Consultation Session to be held from 12pm 2pm on Thursday 26 May 2011. This session will be held at the Artists Exhibition Centre located at 46 Edward Street, Summer Hill.
- Community Consultation Sessions to be held from 4-6pm and 7-9pm on Wednesday 25 May 2011. This session will be held at the Artists Exhibition Centre located at 46 Edward Street, Summer Hill.
